## HOUSE BILL No. 1233

A BILL FOR AN ACT to amend the Indiana Code concerning pensions.

*Be it enacted by the General Assembly of the State of Indiana:*

- 1 SECTION 1. IC 2-3.5-5-2 IS AMENDED TO READ AS  
2 FOLLOWS [EFFECTIVE JULY 1, 2007]: Sec. 2. (a) The defined  
3 contribution fund consists of the following:  
4 (1) Each participant's contributions to the fund.  
5 (2) Contributions made **before July 1, 2007**, to the fund on behalf  
6 of the participants under section 5 of this chapter (**before its  
7 repeal**).  
8 (3) Amounts transferred to the fund under subsections (b) and (c).  
9 (4) All gifts, grants, devises, and bequests in money, property, or  
10 other form made to the fund.  
11 (5) All earnings on investments or on deposits of the funds.  
12 (6) All contributions or payments to the fund made in a manner  
13 provided by the general assembly.  
14 (b) On any July 1 following the date a participant begins  
15 participation in the defined contribution fund, if the participant has  
16 been before that date a member of PERF, any amount in the PERF  
17 annuity savings account credited to the participant may at the



1 participant's irrevocable option be transferred one (1) time to the  
2 defined contribution fund for the benefit of the participant. At no other  
3 time, if the participant continues or begins to participate in PERF, may  
4 such a transfer be made.

5 (c) On any July 1 following the date a participant begins  
6 participation in the defined contribution fund, if the participant has  
7 been before that date a member of TRF, the amount in the TRF annuity  
8 savings account credited to the participant may at the participant's  
9 irrevocable election be transferred one (1) time to the defined  
10 contribution fund for the benefit of the participant. At no other time, if  
11 the participant continues or begins to participate in TRF, may the  
12 transfer be made.

13 (d) Each participant shall be credited individually with:  
14 (1) the participant's contributions to the fund under section 4 of  
15 this chapter, which shall be credited to the participant's account;  
16 (2) the contributions made **before July 1, 2007**, to the fund on  
17 behalf of the participant under section 5 of this chapter (**before its**  
18 **repeal**), which shall be credited to the participant's account;  
19 (3) the amount transferred to the fund under subsections (b) and  
20 (c), which shall be credited to the participant's account; and  
21 (4) the net earnings on the participant's accounts, determined  
22 under section 3 of this chapter.

23 SECTION 2. IC 2-3.5-5-8 IS AMENDED TO READ AS  
24 FOLLOWS [EFFECTIVE JULY 1, 2007]: Sec. 8. (a) For purposes of  
25 this chapter, there is appropriated for each biennium ~~the following~~  
26 ~~sums of money:~~

27 ~~(1) From the state general fund, the amount required to equal the~~  
28 ~~contributions specified in section 5 of this chapter.~~  
29 ~~(2) from the state general fund the amount required for~~  
30 ~~administration of this chapter.~~

31 (b) The biennial appropriation provided in this section shall be  
32 credited to the defined contribution fund annually in the month of July  
33 of each year of the biennium, based on the ~~amounts~~ **amount** specified  
34 in subsection (a).

35 SECTION 3. IC 2-3.5-5-5 IS REPEALED [EFFECTIVE JULY 1,
