DIGEST OF INTRODUCED BILL

Synopsis: Firefighting building and equipment fund. Provides that money in a cumulative firefighting building and equipment fund may also be used for the: (1) maintenance of buildings; (2) purchase of medical supplies; and (3) payment of the paramedic part of a firefighter's salary.

A BILL FOR AN ACT to amend the Indiana Code concerning local government.

Be it enacted by the General Assembly of the State of Indiana:

1 SECTION 1. IC 36-8-14-2 IS AMENDED TO READ AS
2 FOLLOWS [EFFECTIVE JULY 1, 2007]: Sec. 2. (a) As used in this
3 section, "emergency medical services" has the meaning set forth in
4 IC 16-18-2-110.

5 (b) As used in this section, "volunteer fire department" has the
6 meaning set forth in IC 36-8-12-2.

7 (c) The legislative body of a unit or the board of fire trustees of a
8 fire protection district may provide a cumulative building and
9 equipment fund under IC 6-1.1-41 for the following purposes:

- 10 (1) The:
- 11 (A) purchase, construction, renovation, **or maintenance of** or
 - 12 addition to buildings; or
 - 13 (B) purchase of land;
 - 14 used by the fire department or a volunteer fire department serving
 - 15 the unit.

16 (2) The purchase of firefighting equipment for use of the fire
17 department or a volunteer fire department serving the unit,



1 including making the required payments under a lease rental with
 2 option to purchase agreement made to acquire the equipment.
 3 **(3) The purchase of medical supplies used for emergency**
 4 **medical services.**
 5 **(4) The payment of the paramedic part of a firefighter's**
 6 **salary.**
 7 ~~(5)~~ (5) In a municipality, the purchase of police radio equipment.
 8 ~~(4)~~ (6) The:
 9 (A) purchase, construction, renovation, **or maintenance of** or
 10 addition to a building;
 11 (B) purchase of land; or
 12 (C) purchase of equipment;
 13 for use of a provider of emergency medical services under
 14 IC 16-31-5 to the unit establishing the fund.
 15 (d) In addition to the requirements of IC 6-1.1-41, before a
 16 cumulative fund may be established by a township fire protection
 17 district, the county legislative body which appoints the trustees of the
 18 fire protection district must approve the establishment of the fund.
