HOUSE BILL No. 1051**

DIGEST OF HB 1051 (Updated February 6, 2008 2:56 pm - DI 71)

Citations Affected: IC 20-47.

Synopsis: School corporation donations to foundations. Permits a school corporation to annually donate not more than \$25,000 to a community foundation if the donation is matched by a private donor. (Current law permits school corporations to make matched donations only to public school endowment corporations.)

Effective: July 1, 2008.

ENGROSSED HOUSE BILL No. 1051

A BILL FOR AN ACT to amend the Indiana Code concerning education finance.

Be it enacted by the General Assembly of the State of Indiana:

1 SECTION 1. IC 20-47-1-2.5 IS ADDED TO THE INDIANA CODE
2 AS A **NEW** SECTION TO READ AS FOLLOWS [EFFECTIVE JULY
3 1, 2008]: **Sec. 2.5. As used in this chapter, "qualified foundation"**
4 **means:**
5 (1) **a nonprofit charitable community foundation; or**
6 (2) **a public school endowment corporation.**
7 SECTION 2. IC 20-47-1-6, AS ADDED BY P.L.45-2007,
8 SECTION 1, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
9 JULY 1, 2008]: Sec. 6. (a) The governing body of a school corporation
10 may annually donate an amount not to exceed twenty-five thousand
11 dollars (\$25,000) from the general fund of the school corporation to a
12 ~~public school endowment corporation~~ **qualified foundation** under the
13 following conditions:
14 (1) For every dollar that the school corporation donates to the
15 ~~public school endowment corporation;~~ **qualified foundation,** a
16 private individual or entity must donate at least one dollar (\$1) to
