A BILL FOR AN ACT concerning local government.

Be it enacted by the General Assembly of the State of Indiana:

- 1 SECTION 1. [EFFECTIVE JULY 1, 2008] (a) An individual
2 serving as coroner on July 1, 2008, is required to complete the
3 training course required by IC 36-2-14-23(a) before January 1,
4 2009.
5 (b) An individual serving as deputy coroner on July 1, 2008, is
6 required to complete the training course required by
7 IC 36-2-14-23(b) before July 1, 2009.
8 (c) An individual who fails to comply with this SECTION is
9 subject to the penalties set forth in IC 36-2-14-23(e).
10 (d) This SECTION expires December 31, 2012.
