DIGEST OF HB 1318 (Updated January 24, 2008 8:24 am - DI 96)

**Citations Affected:** IC 9-29; IC 16-41; IC 33-37.

**Synopsis:** Funding for spinal cord and brain injury fund and law enforcement continuing education program court fee. Eliminates the \$10 registration fee on motorcycles that is designated for deposit in the spinal cord and brain injury fund. Provides for a fee of fifty cents to be collected after December 31, 2008, for registration of certain vehicles, to be deposited in the spinal cord and brain injury fund. Repeals the law establishing the spinal cord and brain injury fund, and re-enacts the law under a different citation number to resolve a technical conflict between P.L.193-2007 and P.L.234-2007, which resulted in the addition of two different laws with the same citation number. Increases the law enforcement continuing education program fee from \$3 to \$4. Makes an appropriation.

- (1) committed a crime;
- (2) violated a statute defining an infraction; or
- (3) violated an ordinance of a municipal corporation;

the clerk shall collect a law enforcement continuing education program fee of ~~three~~ **four** dollars ~~(\$3)~~ **(\$4)**."
