- 26 **department that occurs within five (5) years of an earlier violation,**
- 27 **the department shall notify the contractor or the agent of the**
- 28 **contractor of the determination and of the right of the contractor**
- 29 **or agent of the contractor to seek a hearing on the determination,**
- 30 **which must be requested in writing within ten (10) working days**
- 31 **after the date of the notice and in accordance with IC 4-21.5-3-2.**
- 32 **The failure to request a hearing within the ten (10) working day**
- 33 **period will result in immediate placement and publication of the**
- 34 **contractor's name on a list maintained on the Internet web site of**
- 35 **the department as required under section 15(b) of this chapter. If**
- 36 **the contractor or agent of the contractor requests a timely hearing,**
- 37 **the commissioner shall set a hearing on the alleged violation. The**
- 38 **hearing must take place not more than forty-five (45) calendar**

- 1 **days after the receipt of the request for the hearing by the**
 2 **department. The hearing must be held in accordance with**
 3 **IC 4-21.5. If the department finds against the contractor or the**
 4 **agent of the contractor, the name of the contractor or the agent of**
 5 **the contractor shall be added to the list. A contract for a public**
 6 **work may not be awarded by the state or a political subdivision to:**
 7 **(1) a contractor whose name appears on the list; or**
 8 **(2) a firm, a corporation, a partnership, or an association in**
 9 **which the contractor has an interest;**
 10 **until four (4) years have elapsed after the posting of the name on**
 11 **the list."**
