### MR. SPEAKER:

*Your Committee on Roads and Transportation, to which was referred House Bill 1318, has had the same under consideration and begs leave to report the same back to the House with the recommendation that said bill **be amended** as follows:*

- 1 Page 1, delete lines 1 through 13, begin a new paragraph and insert:
- 2 "SECTION 1. IC 9-29-5-0.5 IS ADDED TO THE INDIANA CODE
- 3 AS A NEW SECTION TO READ AS FOLLOWS [EFFECTIVE JULY
- 4 1, 2008]: **Sec. 0.5. (a) This section applies after December 31, 2008.**
- 5 **(b) In addition to the fees to be collected for the registration of**
- 6 **a vehicle as set forth in:**
- 7 **(1) IC 9-29-5-1;**
- 8 **(2) IC 9-29-5-2;**
- 9 **(3) IC 9-29-5-3;**
- 10 **(4) IC 9-29-5-5;**
- 11 **(5) IC 9-29-5-7;**
- 12 **(6) IC 9-29-5-8;**
- 13 **(7) IC 9-29-5-9;**
- 14 **(8) IC 9-29-5-10;**
- 15 **(9) IC 9-29-5-18;**
- 16 **(10) IC 9-29-5-28;**

1           **(11) IC 9-29-5-30; and**  
 2           **(12) IC 9-29-5-31;**  
 3           **the bureau shall collect an additional fee of fifty cents (\$0.50) at the**  
 4           **time of the registration.**

5           **(c) The fee collected under subsection (b) shall be deposited into**  
 6           **the spinal cord and brain injury fund under IC 16-41-42.2-3.**

7           SECTION 2. IC 9-29-5-1 IS AMENDED TO READ AS FOLLOWS  
 8           [EFFECTIVE JULY 1, 2008]: Sec. 1. The annual registration fee for a  
 9           passenger motor vehicle is twelve dollars (~~\$12~~); **and fifty cents**  
 10           **(\$12.50), including after December 31, 2008, the fee set forth in**  
 11           **section 0.5(b) of this chapter.**

12           SECTION 3. IC 9-29-5-2, AS AMENDED BY P.L.234-2007,  
 13           SECTION 43, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE  
 14           JULY 1, 2008]: Sec. 2. **(a) This subsection expires December 31,**  
 15           **2008.** The fee for the registration of a motorcycle is twenty-seven  
 16           dollars (\$27). The revenue from this fee shall be allocated as follows:

- 17           (1) Seven dollars (\$7) to the motorcycle operator safety education  
 18           fund established by IC 20-30-13-11.  
 19           (2) An amount prescribed as a license branch service charge  
 20           under IC 9-29-3.  
 21           (3) Ten dollars (\$10) to the spinal cord and brain injury fund  
 22           under IC 16-41-42-4.  
 23           (4) The balance to the state general fund for credit to the motor  
 24           vehicle highway account.

25           **(b) This subsection applies after December 31, 2008. The fee for**  
 26           **the registration of a motorcycle is seventeen dollars and fifty cents**  
 27           **(\$17.50). The revenue from this fee shall be allocated as follows:**

- 28           **(1) Seven dollars (\$7) to the motorcycle operator safety**  
 29           **education fund established by IC 20-30-13-11.**  
 30           **(2) An amount prescribed as a license branch service charge**  
 31           **under IC 9-29-3.**  
 32           **(3) Fifty cents (\$0.50) to the spinal cord and brain injury fund**  
 33           **under IC 16-41-42.2-3, as provided under section 0.5 of this**  
 34           **chapter.**  
 35           **(4) The balance to the state general fund for credit to the**  
 36           **motor vehicle highway account.**

37           SECTION 4. IC 9-29-5-3 IS AMENDED TO READ AS FOLLOWS  
 38           [EFFECTIVE JULY 1, 2008]: Sec. 3. **(a) Except as otherwise provided**

1 in this chapter, the annual registration fee for:  
 2 (1) a truck subject to registration under IC 9-18; and  
 3 (2) a tractor not used with a semitrailer, a traction engine, or other  
 4 similar vehicle used for hauling purposes;  
 5 is as follows:

28 SECTION 5. IC 9-29-5-5 IS AMENDED TO READ AS FOLLOWS  
 29 [EFFECTIVE JULY 1, 2008]: Sec. 5. (a) Except as otherwise provided  
 30 in this chapter, the annual registration fee for a tractor used with a  
 31 semitrailer is as follows, based on the declared gross weight of the  
 32 tractor semitrailer combination:

 18 for each intercity bus or intracity bus is as follows:

2 SECTION 7. IC 9-29-5-8 IS AMENDED TO READ AS FOLLOWS  
3 [EFFECTIVE JULY 1, 2008]: Sec. 8. The annual registration fee for a  
4 school bus is twenty dollars (~~\$20~~); **and fifty cents (\$20.50), including**  
5 **after December 31, 2008, the fee set forth in section 0.5(b) of this**  
6 **chapter.**

7 SECTION 8. IC 9-29-5-9 IS AMENDED TO READ AS FOLLOWS  
8 [EFFECTIVE JULY 1, 2008]: Sec. 9. (a) As used in this section,  
9 "church bus" means a bus that is:

- 10 (1) owned and operated by a religious or nonprofit youth  
11 organization; and  
12 (2) used to transport persons to religious services or used for the  
13 benefit of the members of the religious or nonprofit youth  
14 organization.

15 (b) The annual registration fee for a church bus is twenty dollars  
16 (~~\$20~~); **and fifty cents (\$20.50), including after December 31, 2008,**  
17 **the fee set forth in section 0.5(b) of this chapter.**

18 SECTION 9. IC 9-29-5-10 IS AMENDED TO READ AS  
19 FOLLOWS [EFFECTIVE JULY 1, 2008]: Sec. 10. (a) As used in this  
20 section, "other bus" means a bus that is not a church bus, an intercity  
21 bus, an intracity bus, or a school bus.

22 (b) The annual registration fee for any other bus is thirty dollars  
23 (~~\$30~~); **and fifty cents (\$30.50), including after December 31, 2008,**  
24 **the fee set forth in section 0.5(b) of this chapter.**

25 SECTION 10. IC 9-29-5-18 IS AMENDED TO READ AS  
26 FOLLOWS [EFFECTIVE JULY 1, 2008]: Sec. 18. The fee for a  
27 recreational vehicle is twenty dollars (~~\$20~~); **and fifty cents (\$20.50),**  
28 **including after December 31, 2008, the fee set forth in section**  
29 **0.5(b) of this chapter.**

30 SECTION 11. IC 9-29-5-28, AS AMENDED BY P.L.79-2006,  
31 SECTION 7, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE  
32 JULY 1, 2008]: Sec. 28. Except as provided in IC 9-29-12-2.5(e) and  
33 section 32.5 of this chapter, the registration fee for an antique motor  
34 vehicle under IC 9-18-12 is twelve dollars (~~\$12~~); **and fifty cents**  
35 **(\$12.50), including after December 31, 2008, the fee set forth in**  
36 **section 0.5(b) of this chapter.**

37 SECTION 12. IC 9-29-5-30 IS AMENDED TO READ AS  
38 FOLLOWS [EFFECTIVE JULY 1, 2008]: Sec. 30. (a) The registration

1 fee for a recovery vehicle under IC 9-18-13 is as follows:

2 (1) Class A recovery vehicle, five hundred dollars (\$500).

3 (2) Class B recovery vehicle, seventy-five dollars (\$75).

4 (b) A vehicle registered under IC 9-18-13 is not subject to any other  
5 registration fee under IC 9-18. However, a vehicle registered under  
6 IC 9-18-13 is subject to a tax or service charge **and, after December**  
7 **31, 2008, the fee set forth in section 0.5(b) of this chapter** imposed  
8 on a vehicle registered under this title.

9 SECTION 13. IC 9-29-5-31 IS AMENDED TO READ AS  
10 FOLLOWS [EFFECTIVE JULY 1, 2008]: Sec. 31. (a) The registration  
11 fee for a military vehicle under IC 9-18-14 is twelve dollars ~~(\$12)~~ **and**  
12 **fifty cents (\$12.50), including after December 31, 2008, the fee set**  
13 **forth in section 0.5(b) of this chapter.**

14 (b) The bureau shall collect the fee in subsection (a) in addition to  
15 any excise tax imposed under IC 6-6-5."

16 Page 2, delete lines 19 through 42, begin a new paragraph and  
17 insert:

18 "SECTION 15. IC 33-37-5-8 IS AMENDED TO READ AS  
19 FOLLOWS [EFFECTIVE JULY 1, 2008]: Sec. 8. (a) This section  
20 applies to criminal, infraction, and ordinance violation actions.  
21 However, it does not apply to a case excluded under IC 33-37-4-2(d).

22 (b) The clerk shall collect the alcohol and drug services program fee  
23 set by the court under IC 12-23-14-16 in a county that has established  
24 an alcohol and drug services program.

25 (c) In each action in which a defendant is found to have:

26 (1) committed a crime;

27 (2) violated a statute defining an infraction; or

28 (3) violated an ordinance of a municipal corporation;

29 the clerk shall collect a law enforcement continuing education program

- 1 fee of ~~three~~ **four** dollars (~~\$3~~). (**\$4**)."
- 2 Delete pages 3 through 11.
- 3 Page 12, delete lines 1 through 10.
- 4 Renumber all SECTIONS consecutively.  
(Reference is to HB 1318 as introduced.)
