

SENATE MOTION

MADAM PRESIDENT:

I move that Senate Bill 208 be amended to read as follows:

- 1 Page 2, between lines 30 and 31, begin a new line double block
2 indented and insert:
3 **"However, this clause applies only if the county fiscal body**
4 **has adopted an ordinance under this section to allow**
5 **taxpayers to pay property taxes by automatic deductions**
6 **from a checking account."**
7 Page 2, line 33, after "plan." insert **"However, this clause applies**
8 **only if the county fiscal body has adopted an ordinance under this**
9 **section to allow taxpayers to pay property taxes by monthly**
10 **installment payments under a monthly installment plan."**
11 Page 2, between lines 33 and 34, begin a new line blocked left and
12 insert:
13 **"An ordinance adopted under subsection (e) may include a**
14 **provision authorizing taxpayers to make monthly deductions or**
15 **monthly installment payments in an amount determined by the**
16 **taxpayer that is different from the amount otherwise determined**
17 **by the county treasurer under subsection (h), (i), (j), or (k)."**
18 Page 2, line 34, after "(e)" delete "," and insert **" to allow taxpayers**
19 **to pay property taxes by automatic deductions from a checking**
20 **account,"**.
21 Page 3, line 7, delete "under IC 6-1.1-37-10.3".
22 Page 4, line 13, delete "Notwithstanding this".
23 Page 4, delete lines 14 through 20.
24 Page 5, line 2, delete "IC 6-1.1-37-10.3 and IC 6-1.1-37-10.4" and
25 insert **"IC 6-1.1-37-10 as specified in this section"**.
26 Page 5, line 3, after "account" insert **"or by monthly installment**
27 **payments under a monthly installment plan"**.
28 Page 5, line 15, delete "under" and insert ".".
29 Page 5, delete line 16.
30 Page 5, line 22, delete "that the excess" and insert **"the deficiency"**.
31 Page 5, between lines 41 and 42, begin a new paragraph and insert:

- 1 **"(q) The following apply to a taxpayer that makes automatic**
- 2 **monthly deductions or monthly installments under this section:**
- 3 **(1) If a taxpayer makes automatic monthly deductions or**
- 4 **monthly installments of property taxes in the amount**
- 5 **determined by the county treasurer under subsection (h), (i),**
- 6 **(j), or (k), the taxpayer's property tax payments shall not be**
- 7 **considered delinquent for purposes of IC 6-1.1-37-10 and the**
- 8 **taxpayer is not subject to penalties under that section.**
- 9 **(2) If a taxpayer:**
- 10 **(A) makes automatic monthly deductions or monthly**
- 11 **installments of property taxes in an amount that is less**
- 12 **than the amount determined by the county treasurer under**
- 13 **subsection (h), (i), (j), or (k); and**
- 14 **(B) the total amount of property taxes paid by the taxpayer**
- 15 **under automatic monthly deductions, monthly**
- 16 **installments, or any other method by the May or**
- 17 **November due date is less than the amount determined by**
- 18 **the county treasurer under subsection (h), (i), (j), or (k)**
- 19 **that should have been paid by the taxpayer for the May or**
- 20 **November due date;**
- 21 **the penalty provisions of IC 6-1.1-37-10 apply to the**
- 22 **delinquent property taxes."**
- 23 Page 5, line 42, delete "(q)" and insert "(r)".
- 24 Page 5, line 42, after "to" insert "**any amounts due under**".
- 25 Page 6, line 1, delete "in the same manner that IC 6-1.1-37-10" and
- 26 insert "**that are not paid within thirty (30) days after the date of the**
- 27 **reconciling statement, as required under subsection (n)(3)."**
- 28 Page 6, delete line 2.
- 29 Page 6, line 3, delete "(r)" and insert "(s)".
- 30 Page 6, delete lines 36 through 42.
- 31 Delete pages 7 through 11.
- 32 Re-number all SECTIONS consecutively.
