3 JULY 1, 2009]: Sec. 6.5. As used in this chapter, "unit" means a city,
4 town, county, ~~or~~ township, **school corporation (as defined in**
5 **IC 20-18-2-16(a)), or a college or university (as defined in**
6 **IC 21-7-13-10).**
