HOUSE MOTION _____

MR. SPEAKER:

I move that House Bill 1653 be amended to read as follows:

- 1 Page 1, between the enacting clause and line 1, begin a new
- 2 paragraph and insert:
- 3 "SECTION 1. IC 12-15-2.5-4 IS AMENDED TO READ AS
- 4 FOLLOWS [EFFECTIVE JULY 1, 2009]: Sec. 4. A child who:
- 5 (1) is born in the United States to a person described in section 2
- 6 or 3 of this chapter; and
- 7 (2) otherwise meets the requirements for assistance under this
- 8 article;
- 9 is eligible to receive Medicaid under this article."
- 10 Page 2, after line 15, begin a new paragraph and insert:
- 11 "SECTION 3. THE FOLLOWING ARE REPEALED [EFFECTIVE
- 12 JULY 1, 2009]: IC 12-15-2.5-1; IC 12-15-2.5-2.
- 13 SECTION 4. [EFFECTIVE JULY 1, 2009] (a) As used in this
- 14 SECTION, "office" refers to the office of Medicaid policy and
- 15 planning established by IC 12-8-6-1.
- 16 (b) Before September 1, 2009, the office shall apply to the United
- 17 States Department of Health and Human Services for an
- 18 amendment to the state Medicaid plan or for a demonstration
- 19 waiver to amend the state's Medicaid eligibility requirements to
- 20 limit Medicaid services provided under IC 12-15 to legal residents
- 21 of the United States.
- 22 (c) The office may not implement the state plan amendment or
- 23 demonstration waiver until the office files an affidavit with the
- 24 governor attesting that the state plan amendment or demonstration

1 **waiver applied for under this SECTION is in effect. The office shall**
2 **file the affidavit under this subsection not later than five (5) days**
3 **after the office is notified that the state plan amendment or**
4 **demonstration waiver is approved.**

5 **(d) If the office receives approval to the state plan amendment**
6 **or demonstration waiver applied for under this SECTION from**
7 **the United States Department of Health and Human Services and**
8 **the governor receives the affidavit filed under subsection (c), the**
9 **office shall implement the state plan amendment or demonstration**
10 **waiver not more than sixty (60) days after the governor receives**
11 **the affidavit.**

12 **(e) The office may adopt rules under IC 4-22-2 necessary to**
13 **implement this SECTION.**

14 **(f) This SECTION expires December 31, 2014."**

15 Renumber all SECTIONS consecutively.
