# SENATE BILL No. 60

## DIGEST OF INTRODUCED BILL

**Citations Affected:** IC 24-4-17.

**Synopsis:** Prohibit retention of certain access device data. Prohibits a person that accepts an access device card, such as a credit card, debit card, or stored value card, in connection with a transaction, from retaining the card security code, the PIN verification code number, or the full contents of the information contained in the magnetic stripe or microprocessor chip of the access device: (1) after authorization of the transaction if the transaction is not a PIN debit transaction; or (2) more than 48 hours after authorization of the transaction if the transaction is a PIN debit transaction. Provides that a person violates this prohibition if the person's service provider retains the information. Requires a person that violates the prohibition to reimburse a state or federally chartered or federally insured financial institution for the costs associated with a breach of the security of a system of the person or the person's service provider.

**Effective:** July 1, 2009.

## SENATE BILL No. 60



A BILL FOR AN ACT to amend the Indiana Code concerning trade regulation.

*Be it enacted by the General Assembly of the State of Indiana:*

1 SECTION 1. IC 24-4-17 IS ADDED TO THE INDIANA CODE AS  
2 A **NEW** CHAPTER TO READ AS FOLLOWS [EFFECTIVE JULY  
3 1, 2009]:

4 **Chapter 17. Access Devices; Breach of Security**

5 **Sec. 1. (a) As used in this chapter, "access device" means a card**  
6 **issued by a financial institution that contains:**

- 7 (1) a magnetic stripe;
- 8 (2) a microprocessor chip; or
- 9 (3) other means for storing information.

10 (b) The term includes a credit card, debit card, or stored value  
11 card.

12 **Sec. 2. As used in this chapter, "breach of the security of a**  
13 **system" has the meaning set forth in IC 24-4.9-2-2.**

14 **Sec. 3. As used in this chapter, "card security code" means the**  
15 **three (3) or four (4) digit code used to validate information stored**  
16 **on an access device during the authorization process that is:**

- 17 (1) printed on an access device; or



1           (2) contained in one (1) or more of the following of an access  
 2           device:  
 3           (A) A microprocessor chip.  
 4           (B) A magnetic stripe.  
 5           (C) Any other means used to store information.  
 6           Sec. 4. As used in this chapter, "state or federally chartered or  
 7           federally insured financial institution" has the meaning set forth in  
 8           IC 35-43-5-8(b).  
 9           Sec. 5. As used in this chapter, "person" has the meaning set  
 10          forth in IC 24-4.9-2-9.  
 11          Sec. 6. As used in this chapter, "PIN" means a personal  
 12          identification code that identifies the cardholder.  
 13          Sec. 7. As used in this chapter, "PIN verification code number"  
 14          means the data used to verify a cardholder's identity when a PIN  
 15          is used in a transaction.  
 16          Sec. 8. As used in this chapter, "service provider" means a  
 17          person that stores, processes, or transmits information stored on  
 18          an access device on behalf of another person.  
 19          Sec. 9. (a) A person that accepts an access device in connection  
 20          with a transaction may not retain the card security code, the PIN  
 21          verification code number, or the full contents of the information  
 22          contained in the magnetic stripe or microprocessor chip of the  
 23          access device:  
 24                  (1) after authorization of the transaction if the transaction is  
 25                  not a PIN debit transaction; or  
 26                  (2) more than forty-eight (48) hours after authorization of the  
 27                  transaction if the transaction is a PIN debit transaction.  
 28          (b) A person violates this section if a service provider of the  
 29          person retains the data described under subsection (a):  
 30                  (1) after authorization of the transaction if the transaction is  
 31                  not a PIN debit transaction; or  
 32                  (2) more than forty-eight (48) hours after authorization of the  
 33                  transaction if the transaction is a PIN debit transaction.  
 34          Sec. 10. (a) As used in this section, "costs" include the cost of:  
 35                  (1) canceling or reissuing an access device;  
 36                  (2) closing a deposit, transaction, share draft, or other account  
 37                  and an action to stop payment or block transaction with  
 38                  respect to the account;  
 39                  (3) opening or reopening a deposit, transaction, share draft,  
 40                  or other account;  
 41                  (4) refunding or crediting a cardholder to cover the cost of an  
 42                  unauthorized transaction;

1           (5) notifying a cardholder; and  
 2           (6) damages paid to a cardholder injured by a breach of the  
 3           security of a system.  
 4       **The term does not include any costs that a state or federally**  
 5       **chartered or federally insured financial institution recovers from**  
 6       **a credit card vendor.**  
 7       **(b) If there is a breach of the security of a system of:**  
 8           **(1) a person that violated section 9 of this chapter; or**  
 9           **(2) a person's service provider that retained data as described**  
 10          **in section 9(b) of this chapter;**  
 11       **the person shall reimburse a state or federally chartered or**  
 12       **federally insured financial institution that issued an access device**  
 13       **that is affected by the breach of the security of a system for the**  
 14       **costs of reasonable actions undertaken by the state or federally**  
 15       **chartered or federally insured financial institution as a result of the**  
 16       **breach of the security of a system to protect the information of a**  
 17       **cardholder or to continue to provide services to a cardholder.**  
 18       **(c) This section does not restrict any other right or remedy**  
 19       **otherwise available to a state or federally chartered or federally**  
 20       **insured financial institution.**
