

SENATE MOTION

MADAM PRESIDENT:

I move that Engrossed House Bill 1130 be amended to read as follows:

- 1 Page 2, after line 19, begin a new paragraph and insert:
2 "SECTION 2. IC 9-24-12-5, AS AMENDED BY P.L.156-2006,
3 SECTION 14, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
4 JULY 1, 2009]: Sec. 5. **(a) Except as provided in subsection (b),** an
5 individual applying for renewal of an operator's, a motorcycle
6 operator's, a chauffeur's, or a public passenger chauffeur's license must
7 apply in person at a license branch and do the following:
8 (1) Pass an eyesight examination.
9 (2) Pass a written examination if:
10 (A) the applicant has at least six (6) active points on the
11 applicant's driving record maintained by the bureau; or
12 (B) the applicant holds a valid operator's license, has not
13 reached the applicant's twenty-first birthday, and has active
14 points on the applicant's driving record maintained by the
15 bureau.
16 **(b) The bureau may adopt rules under IC 4-22-2 concerning**
17 **the ability of a holder of an operator's, a motorcycle operator's, a**
18 **chauffeur's, or a public passenger chauffeur's license to renew the**
19 **license by mail or by electronic service. If rules are adopted under**
20 **this subsection, the rules must provide that an individual's renewal**
21 **of a license by mail or by electronic service is subject to the**
22 **following conditions:**
23 **(1) A valid computerized image of the individual must exist**
24 **within the records of the bureau.**
25 **(2) The previous renewal of the individual's operator's,**
26 **motorcycle operator's, chauffeur's, or public passenger**
27 **chauffeur's license must not have been by mail or by**
28 **electronic service.**
29 **(3) The application for or previous renewal of the**
30 **individual's license must have included a test of the**
31 **individual's eyesight approved by the bureau.**
32 **(4) If the individual were applying for the license renewal in**

1 **person at a license branch, the individual would not be**
2 **required under subsection (a)(2) to submit to a written**
3 **examination.**
4 **(5) The individual must be a citizen of the United States, as**
5 **shown in the records of the bureau.**
6 **(6) There must not have been any change in the:**
7 **(A) address; or**
8 **(B) name;**
9 **of the individual since the issuance or previous renewal of**
10 **the individual's operator's, motorcycle operator's,**
11 **chauffeur's, or public passenger chauffeur's license.**
12 **(7) The operator's, motorcycle operator's, chauffeur's, or**
13 **public passenger chauffeur's license of the individual must**
14 **not be:**
15 **(A) suspended; or**
16 **(B) expired;**
17 **at the time of the application for renewal.**
18 **(8) The individual must be less than seventy-five (75) years**
19 **of age at the time of the application for renewal.**
20 **(c) An individual applying for the renewal of an operator's, a**
21 **motorcycle operator's, a chauffeur's, or a public passenger**
22 **chauffeur's license must apply in person at a license branch under**
23 **subsection (a) if the individual is not entitled to apply by mail or by**
24 **electronic service under rules adopted under subsection (b)."**
