MR. SPEAKER:

I move that Engrossed Senate Bill 239 be amended to read as follows:

- 1 Page 67, between lines 17 and 18, begin a new paragraph and insert:
- 2 "SECTION 41. IC 36-4-6-5, AS AMENDED BY P.L.230-2005,
- 3 SECTION 87, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
- 4 JULY 1, 2010]: Sec. 5. (a) This section applies to third class cities
- 5 having a population of less than ten thousand (10,000). The legislative
- 6 body of such a city may, by ordinance adopted ~~before September 1,~~
- 7 ~~1982,~~ **after June 30, 2010, and during a year in which an election**
- 8 **of the legislative body will not occur,** decide to be governed by this
- 9 section instead of section 4 of this chapter. ~~If this ordinance is repeated~~
- 10 ~~after August 31, 1982, except as a part of a codification of ordinances~~
- 11 ~~that reenacts the ordinance under IC 36-1-5-6, then section 4 of this~~
- 12 ~~chapter again applies to the city. The legislative body districts~~
- 13 **created by an ordinance adopted under this subsection apply to the**
- 14 **first election of the legislative body held after the date the**
- 15 **ordinance is adopted.** The clerk of the legislative body shall send a
- 16 certified copy of any ordinance adopted under this subsection to the
- 17 secretary of the county election board.
- 18 (b) This subsection does not apply to a city with an ordinance
- 19 described by subsection (j). The legislative body shall adopt an
- 20 ordinance to divide the city into four (4) districts that:
- 21 (1) are composed of contiguous territory, except for territory that
- 22 is not contiguous to any other part of the city;
- 23 (2) are reasonably compact;
- 24 (3) do not cross precinct boundary lines except as provided in

- 1 subsection (c) or (d); and
 2 (4) contain, as nearly as is possible, equal population.
- 3 (c) The boundary of a city legislative body district may cross a
 4 precinct boundary line if:
- 5 (1) more than one (1) member of the legislative body elected from
 6 the districts established under subsection (b) or (j) resides in one
 7 (1) precinct established under IC 3-11-1.5 after the most recent
 8 municipal election; and
- 9 (2) following the establishment of a legislative body district
 10 whose boundary crosses a precinct boundary line, not more than
 11 one (1) member of the legislative body elected from the districts
 12 resides within the same city legislative body district.
- 13 (d) The boundary of a city legislative body district may cross a
 14 precinct line if the districts would not otherwise contain, as nearly as
 15 is possible, equal population.
- 16 (e) A city legislative body district with a boundary described by
 17 subsection (c) or (d) may not cross a census block boundary line:
- 18 (1) except when following a precinct boundary line; or
 19 (2) unless the city legislative body certifies in the ordinance that
 20 the census block has no population, and is not likely to ever have
 21 population.
- 22 (f) The legislative body may not adopt an ordinance dividing the city
 23 into districts with boundaries described by subsection (c) or (d) unless
 24 the clerk of the city mails a written notice to the circuit court clerk. The
 25 notice must:
- 26 (1) state that the legislative body is considering the adoption of an
 27 ordinance described by this subsection; and
 28 (2) be mailed not later than ten (10) days before the legislative
 29 body adopts the ordinance.
- 30 (g) The division under subsection (b) or (j) shall be made:
- 31 (1) during the second year after a year in which a federal
 32 decennial census is conducted; and
 33 (2) when required to assign annexed territory to a district.
- 34 This division may be made at any other time, subject to IC 3-11-1.5-32.
- 35 (h) This subsection does not apply to a city with an ordinance
 36 described by subsection (j). The legislative body is composed of four
 37 (4) members elected from the districts established under subsection (b)
 38 and one (1) at-large member.
- 39 (i) This subsection does not apply to a city with an ordinance
 40 described by subsection (j). Each voter may vote for one (1) candidate
 41 for at-large membership and one (1) candidate from the district in
 42 which the voter resides. The at-large candidate receiving the most votes
 43 from the whole city and the district candidates receiving the most votes
 44 from their respective districts are elected to the legislative body.
- 45 (j) A city may adopt an ordinance under this subsection to divide the
 46 city into three (3) districts that:

- 1 (1) are composed of contiguous territory, except for territory that
 2 is not contiguous to any other part of the city;
- 3 (2) are reasonably compact;
- 4 (3) do not cross precinct boundary lines, except as provided in
 5 subsection (c) or (d); and
- 6 (4) contain, as nearly as is possible, equal population.
- 7 (k) This subsection applies to a city with an ordinance described by
 8 subsection (j). The legislative body is composed of three (3) members
 9 elected from the districts established under subsection (j) and two (2)
 10 at-large members.
- 11 (l) This subsection applies to a city with an ordinance described by
 12 subsection (j). Each voter of the city may vote for two (2) candidates
 13 for at-large membership and one (1) candidate from the district in
 14 which the voter resides. The two (2) at-large candidates receiving the
 15 most votes from the whole city and the district candidates receiving the
 16 most votes from their respective districts are elected to the legislative
 17 body.
- 18 (m) This subsection applies to a city having a population of less than
 19 seven thousand (7,000). A legislative body of such a city that has, by
 20 resolution adopted before May 7, 1991, decided to continue an election
 21 process that permits each voter of the city to vote for one (1) candidate
 22 at large and one (1) candidate from each of its four (4) council districts
 23 may hold elections using that voting arrangement. The at-large
 24 candidate and the candidate from each district receiving the most votes
 25 from the whole city are elected to the legislative body. The districts
 26 established in cities adopting such a resolution may cross precinct
 27 boundary lines.
- 28 (n) A copy of the ordinance establishing districts under this section
 29 must be filed with the circuit court clerk of the county that contains the
 30 greatest population of the city not later than thirty (30) days after the
 31 ordinance is adopted.
- 32 (o) If any territory in the city is not included in one (1) of the
 33 districts established under this section, the territory is included in the
 34 district that:
- 35 (1) is contiguous to that territory; and
 36 (2) contains the least population of all districts contiguous to that
 37 territory.
- 38 (p) If any territory in the city is included in more than one (1) of the
 39 districts established under this section, the territory is included in the
 40 district that:
- 41 (1) is one (1) of the districts in which the territory is described in
 42 the ordinance adopted under this section;
 43 (2) is contiguous to that territory; and
 44 (3) contains the least population of all districts contiguous to that
 45 territory."
- 46 Renumber all SECTIONS consecutively.
