I move that House Bill 1276 be amended to read as follows:

- 1 Page 3, between lines 22 and 23, begin a new line block indented
- 2 and insert:
- 3 **"(12) Study and make recommendations regarding whether**
- 4 **the criminal justice institute should collect information**
- 5 **regarding domestic violence that occurs in Indiana and**
- 6 **whether the information should be reported to the National**
- 7 **Incident-Based Reporting System within the Federal Bureau**
- 8 **of Investigation.**
- 9 **(13) Study and make recommendations regarding whether the**
- 10 **211 telephone dialing code service should assist parents with**
- 11 **stress issues.**
- 12 **(14) Study and make recommendations regarding whether a**
- 13 **defendant charged with an act involving compelling another**
- 14 **person to engage in sexual activity by force or threat may be**
- 15 **required to be tested for the human immunodeficiency virus**
- 16 **(HIV) at the alleged victim's request.**
- 17 **(15) Study and make recommendations regarding whether a**
- 18 **school corporation should be required to provide instruction**
- 19 **or programs regarding domestic violence.**
- 20 **(16) Study and make recommendations regarding whether the**
- 21 **definition of "bullying," for purposes of IC 20-33-8, should be**
- 22 **amended to include "communications transmitted from an**
- 23 **electronic communications device or through a social**
- 24 **networking web site".**

- 1 **(17) Study and make recommendations regarding whether a**
- 2 **postsecondary institution should be required to adopt policies**
- 3 **concerning student notification of dangerous situations**
- 4 **occurring on and off campus.**
- 5 **(18) Study and make recommendations regarding whether a**
- 6 **person convicted of domestic battery should be allowed to**
- 7 **have only supervised visitation with the person's child.**
- 8 **(19) Study and make recommendations regarding whether the**
- 9 **division of state court administration should report to the**
- 10 **general assembly or a study committee concerning:**
- 11 **(A) the implementation of the judicial technology and**
- 12 **automation project; and**
- 13 **(B) statistics compiled by the judicial technology and**
- 14 **automation project regarding the number of dissolution of**
- 15 **marriage decrees entered in Indiana.**
- 16 **(20) Study and make recommendations regarding whether the**
- 17 **time during which a facility has custody of a person arrested**
- 18 **for a crime of domestic violence should be extended to**
- 19 **twenty-four (24) hours.**
- 20 **(21) Study and make recommendations regarding whether a**
- 21 **person who has been charged with domestic violence should**
- 22 **be required to wear a GPS tracking device as a condition of**
- 23 **bail.**
- 24 **(22) Study and make recommendations regarding whether a**
- 25 **person convicted of domestic battery should be required to**
- 26 **complete a batterer's intervention program."**
