MR. SPEAKER:

I move that Engrossed Senate Bill 405 be amended to read as follows:

- 1 Page 1, between the enacting clause and line 1, begin a new
- 2 paragraph and insert:
- 3 "SECTION 1. IC 4-31-5-11 IS AMENDED TO READ AS
- 4 FOLLOWS [EFFECTIVE UPON PASSAGE]: Sec. 11. **(a) This**
- 5 **subsection applies to quarter horse and standardbred racing.** The
- 6 commission may require each permit holder to schedule one (1) or
- 7 more races on each racing day:
- 8 (1) solely for Indiana owned horses;
- 9 (2) solely for Indiana sired horses;
- 10 (3) solely for Indiana bred horses; or
- 11 (4) for a combination of Indiana owned horses, Indiana sired
- 12 horses, and Indiana bred horses.
- 13 **(b) This subsection applies to thoroughbred racing. The**
- 14 **commission shall require each permit holder to schedule two (2) or**
- 15 **more races on each racing day:**
- 16 (1) solely for Indiana owned horses;
- 17 (2) solely for Indiana sired horses;
- 18 (3) solely for Indiana bred horses; or
- 19 (4) for a combination of Indiana owned horses, Indiana sired
- 20 horses, and Indiana bred horses."
- 21 Page 6, between lines 15 and 16, begin a new paragraph and insert:
- 22 "SECTION 6. IC 4-31-11-0.3 IS ADDED TO THE INDIANA
- 23 CODE AS A **NEW** SECTION TO READ AS FOLLOWS
- 24 [EFFECTIVE UPON PASSAGE]: **Sec. 0.3. As used in this chapter,**

1 **"base purse" means an amount equal to seventy percent (70%) of**
 2 **the equivalent open race purse for a race of the same class and**
 3 **condition that is:**

4 **(1) not a stakes race; and**

5 **(2) for a claiming price of at least ten thousand dollars**
 6 **(\$10,000).**

7 SECTION 7. IC 4-31-11-0.7 IS ADDED TO THE INDIANA CODE
 8 AS A **NEW SECTION** TO READ AS FOLLOWS [EFFECTIVE
 9 UPON PASSAGE]: **Sec. 0.7. As used in this chapter, "breeder**
 10 **award" refers to a monetary award paid to the breeder of any**
 11 **registered Indiana bred or sired horse that:**

12 **(1) in the case of a standardbred or quarter horse, satisfies the**
 13 **requirements of an awards program established by the**
 14 **commission; or**

15 **(2) in the case of a thoroughbred, wins a race at an Indiana**
 16 **racetrack for a claiming price of at least ten thousand dollars**
 17 **(\$10,000).**

18 SECTION 8. IC 4-31-11-2.3 IS ADDED TO THE INDIANA CODE
 19 AS A **NEW SECTION** TO READ AS FOLLOWS [EFFECTIVE
 20 UPON PASSAGE]: **Sec. 2.3. As used in this chapter, "owner**
 21 **award" refers to a monetary award paid to the owner of any**
 22 **registered Indiana bred or sired horse that:**

23 **(1) in the case of a standardbred or quarter horse, satisfies the**
 24 **requirements of an awards program established by the**
 25 **commission; or**

26 **(2) in the case of a thoroughbred, wins a race at an Indiana**
 27 **racetrack for a claiming price of at least ten thousand dollars**
 28 **(\$10,000).**

29 SECTION 9. IC 4-31-11-2.7 IS ADDED TO THE INDIANA CODE
 30 AS A **NEW SECTION** TO READ AS FOLLOWS [EFFECTIVE
 31 UPON PASSAGE]: **Sec. 2.7. As used in this chapter, "stallion owner**
 32 **award" refers to a monetary award paid to the owner of a**
 33 **registered Indiana stallion whose progeny:**

34 **(1) in the case of a standardbred or quarter horse, satisfies the**
 35 **requirements of an awards program established the**
 36 **commission; or**

37 **(2) in the case of a thoroughbred, wins a race at an Indiana**
 38 **racetrack for a claiming price of at least ten thousand dollars**
 39 **(\$10,000).**

40 SECTION 10. IC 4-31-11-3 IS AMENDED TO READ AS
 41 FOLLOWS [EFFECTIVE UPON PASSAGE]: **Sec. 3. The commission**
 42 **may shall** establish a separate breed development advisory committee
 43 for each breed of horse that participates in racing meetings under this
 44 article.

45 SECTION 11. IC 4-31-11-9 IS AMENDED TO READ AS
 46 FOLLOWS [EFFECTIVE UPON PASSAGE]: **Sec. 9. (a) Each**
 47 **development committee may shall** make recommendations to the

- 1 commission concerning:
 2 (1) stakes races;
 3 (2) futurity races;
 4 (3) races only for horses owned by Indiana residents;
 5 (4) races only for horses sired by stallions standing in Indiana;
 6 (5) races only for horses foaled in Indiana; or
 7 (6) races for any combination of horses described in subdivision
 8 (3), (4), or (5).

9 Races described in subdivisions (3) through (6) may be for different
 10 distances and may be limited by the age, sex, or gait of the horse.

11 (b) Each development committee may make recommendations to
 12 the commission concerning:

- 13 (1) cooperative arrangements with statewide breed associations;
 14 and
 15 (2) distribution of money available in a development fund in order
 16 to supplement a purse for a race at a county fair or agricultural
 17 exposition in Indiana.

18 SECTION 12. IC 4-31-11-10 IS AMENDED TO READ AS
 19 FOLLOWS [EFFECTIVE UPON PASSAGE]: Sec. 10. The
 20 commission ~~may~~ **shall** establish a separate breed development fund for
 21 each breed of horse that participates in racing meetings under this
 22 article. The development funds shall be administered by the
 23 commission."

24 Page 6, between lines 24 and 25, begin a new paragraph and insert:

25 "SECTION 14. IC 4-31-11-15 IS AMENDED TO READ AS
 26 FOLLOWS [EFFECTIVE UPON PASSAGE]: Sec. 15. **(a)** The
 27 commission shall use the development funds **for the following**
 28 **purposes:**

- 29 (1) To provide purses and ~~other funding for the activities awards~~
 30 **for races** described in section 9 of this chapter **as required by:**
 31 **(A) section 16 of this chapter, in the case of thoroughbred**
 32 **racing; or**
 33 **(B) the rules of a program established by the commission,**
 34 **in the case of standardbred or quarter horse racing.**
 35 **(2) To fund cooperative arrangements described in section**
 36 **9(b)(1) of this chapter.**
 37 **(3) To fund recommendations, if any, made under section**
 38 **9(b)(2) of this chapter.**

39 **(b) The commission may not use money in the development**
 40 **funds to pay administrative expenses incurred by the commission.**

41 SECTION 15. IC 4-31-11-16 IS ADDED TO THE INDIANA
 42 CODE AS A NEW SECTION TO READ AS FOLLOWS
 43 [EFFECTIVE UPON PASSAGE]: Sec. 16. **(a) This section applies**
 44 **only to money distributed to the breed development fund for**
 45 **thoroughbreds.**

46 **(b) The money must be used as follows:**

- 1 **(1) To provide purses and supplements for races restricted to**
- 2 **Indiana bred or sired horses, or a combination of Indiana**
- 3 **bred or sired horses.**
- 4 **(2) To pay the following awards:**
- 5 **(A) Owner awards.**
- 6 **(B) Breeder awards.**
- 7 **(C) Stallion owner awards.**
- 8 **(c) Money used to provide purses under subsection (b) must**
- 9 **supplement the base purse provided from the horse industry trust**
- 10 **account established under the rules of the commission.**
- 11 **(d) An award paid under subsection (b) is equal to the following**
- 12 **amounts:**
- 13 **(1) Twenty percent (20%) of the total purse of the race for**
- 14 **which the award is made, including any purse supplements, in**
- 15 **the case of an owner award or a breeder award.**
- 16 **(2) Ten percent (10%) of the total purse of the race for which**
- 17 **the award is made, including any purse supplements, in the**
- 18 **case of a stallion owner award."**
- 19 Page 34, line 18, delete "." and insert "**to be used as required by**
- 20 **IC 4-31-11-16."**
- 21 Renumber all SECTIONS consecutively.
