DIGEST OF HB 1064 (Updated January 7, 2010 10:41 am - DI 52)

Citations Affected: IC 14-9; IC 14-22.

Synopsis: Wild game donations. Establishes a procedure to collect voluntary donations when hunting licenses are sold. Specifies that the proceeds must be used to process donated wild game related to feeding the state's hungry. (The introduced version of this bill was prepared by the natural resources study committee.)

Effective: July 1, 2010.

HOUSE BILL No. 1064

A BILL FOR AN ACT to amend the Indiana Code concerning natural and cultural resources.

Be it enacted by the General Assembly of the State of Indiana:

- 1 SECTION 1. IC 14-9-5-4, AS ADDED BY P.L.66-2008, SECTION
2 3, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE JULY 1,
3 2010]: Sec. 4. (a) As used in this section, "account" means the Indiana
4 sportsmen's benevolence account established by subsection (b).
5 (b) The Indiana sportsmen's benevolence account is established
6 within the fund for the division of law enforcement to encourage
7 citizen participation in feeding the state's hungry through donations of
8 wild game that has been lawfully hunted.
9 (c) The account consists of:
10 (1) gifts;
11 (2) donations; ~~and~~
12 (3) proceeds derived from marketing by the division of law
13 enforcement of goods related to the feeding of the state's hungry
14 through donations of wild game under subsection (a); ~~and~~
15 (4) **donations collected under IC 14-22-12-1(c)**.
16 (d) The expenses of administering the account shall be paid from
17 money in the account.

- 19 licenses and, except as provided in section 1.5 of this chapter and
- 20 subject to subsection (b), shall charge the following minimum license
- 21 fees to hunt, trap, or fish in Indiana:
- 22 (1) A resident yearly license to fish, eight dollars and seventy-five
- 23 cents (\$8.75).
- 24 (2) A resident yearly license to hunt, eight dollars and
- 25 seventy-five cents (\$8.75).
- 26 (3) A resident yearly license to hunt and fish, thirteen dollars and
- 27 seventy-five cents (\$13.75).
- 28 (4) A resident yearly license to trap, eight dollars and seventy-five
- 29 cents (\$8.75).
- 30 (5) A nonresident yearly license to fish, twenty-four dollars and
- 31 seventy-five cents (\$24.75).
- 32 (6) A nonresident yearly license to hunt, sixty dollars and
- 33 seventy-five cents (\$60.75).
- 34 (7) A nonresident yearly license to trap, one hundred seventeen
- 35 dollars and seventy-five cents (\$117.75). However, a license may
- 36 not be issued to a resident of another state if that state does not
- 37 give reciprocity rights to Indiana residents similar to those
- 38 nonresident trapping privileges extended in Indiana.
- 39 (8) A resident or nonresident license to fish, including for trout
- 40 and salmon, for one (1) day only, four dollars and seventy-five
- 41 cents (\$4.75).
- 42 (9) A nonresident license to fish, excluding for trout and salmon,

- 1 for seven (7) days only, twelve dollars and seventy-five cents
 2 (\$12.75).
 3 (10) A nonresident license to hunt for five (5) consecutive days
 4 only, twenty-five dollars and seventy-five cents (\$25.75).
 5 (11) A resident or nonresident yearly stamp to fish for trout and
 6 salmon, six dollars and seventy-five cents (\$6.75).
 7 (12) A resident yearly license to take a deer with a shotgun,
 8 muzzle loading gun, rifle, or handgun, thirteen dollars and
 9 seventy-five cents (\$13.75).
 10 (13) A resident yearly license to take a deer with a muzzle loading
 11 gun, thirteen dollars and seventy-five cents (\$13.75).
 12 (14) A resident yearly license to take a deer with a bow and
 13 arrow, thirteen dollars and seventy-five cents (\$13.75).
 14 (15) A nonresident yearly license to take a deer with a shotgun,
 15 muzzle loading gun, rifle, or handgun, one hundred twenty dollars
 16 and seventy-five cents (\$120.75).
 17 (16) A nonresident yearly license to take a deer with a muzzle
 18 loading gun, one hundred twenty dollars and seventy-five cents
 19 (\$120.75).
 20 (17) A nonresident yearly license to take a deer with a bow and
 21 arrow, one hundred twenty dollars and seventy-five cents
 22 (\$120.75).
 23 (18) A resident license to take an extra deer by a means, in a
 24 location, and under conditions established by rule adopted by the
 25 department under IC 4-22-2, five dollars (\$5).
 26 (19) A nonresident license to take an extra deer by a means, in a
 27 location, and under conditions established by rule adopted by the
 28 department under IC 4-22-2, ten dollars (\$10).
 29 (20) A resident yearly license to take a turkey, fourteen dollars
 30 and seventy-five cents (\$14.75).
 31 (21) A nonresident yearly license to take a turkey, one hundred
 32 fourteen dollars and seventy-five cents (\$114.75). However, if the
 33 state of residence of the nonresident applicant requires that before
 34 a resident of Indiana may take turkey in that state the resident of
 35 Indiana must also purchase another license in addition to a
 36 nonresident license to take turkey, the applicant must also
 37 purchase a nonresident yearly license to hunt under this section.
 38 (22) A resident license to take an extra turkey by a means, in a
 39 location, and under conditions established by rule adopted by the
 40 department under IC 4-22-2, fourteen dollars and seventy-five
 41 cents (\$14.75).
 42 (23) A nonresident license to take an extra turkey by a means, in

1 a location, and under conditions established by rule adopted by
 2 the department under IC 4-22-2, one hundred fourteen dollars and
 3 seventy-five cents (\$114.75). However, if the state of residence of
 4 the nonresident applicant requires that before a resident of
 5 Indiana may take a turkey in that state the resident of Indiana
 6 must also purchase another license in addition to a nonresident
 7 license to take a turkey, the applicant must also purchase a
 8 nonresident yearly license to hunt under this section.

9 (24) A resident youth yearly consolidated license to hunt, trap,
 10 and fish, six dollars (\$6). This license is subject to the following:

11 (A) An applicant must be less than eighteen (18) years of age.
 12 (B) The license is in lieu of the resident yearly license to hunt,
 13 trap, and fish and all other yearly licenses, stamps, or permits
 14 to hunt, trap, and fish for a specific species or by a specific
 15 means.

16 (25) A nonresident youth yearly license to hunt, seventeen dollars
 17 (\$17). The applicant must be less than eighteen (18) years of age.
 18 (26) A nonresident youth yearly license to trap, seventeen dollars
 19 (\$17). The applicant must be less than eighteen (18) years of age.
 20 (27) A nonresident youth yearly license to take a turkey,
 21 twenty-five dollars (\$25). The applicant must be less than
 22 eighteen (18) years of age. However, if the state of residence of
 23 the nonresident applicant requires that before a resident of
 24 Indiana may take a turkey in that state the resident of Indiana
 25 must also purchase another license in addition to a nonresident
 26 license to take a turkey, the applicant must also purchase a
 27 nonresident youth yearly license to hunt under this section.

28 (28) A nonresident youth license to take an extra turkey by a
 29 means, in a location, and under conditions established by rule
 30 adopted by the department under IC 4-22-2, twenty-five dollars
 31 (\$25). The applicant must be less than eighteen (18) years of age.
 32 However, if the state of residence of the nonresident applicant
 33 requires that before a resident of Indiana may take a turkey in that
 34 state the resident of Indiana must also purchase another license in
 35 addition to a nonresident license to take a turkey, the applicant
 36 must also purchase a nonresident youth yearly license to hunt
 37 under this section.

38 (29) A nonresident youth yearly license to take a deer with a
 39 shotgun, muzzle loading gun, or rifle, twenty-four dollars (\$24).
 40 The applicant must be less than eighteen (18) years of age.
 41 (30) A nonresident youth yearly license to take a deer with a
 42 muzzle loading gun, twenty-four dollars (\$24). The applicant

- 2 (31) A nonresident youth yearly license to take a deer with a bow

- 6 in a location, and under conditions established by rule adopted by

- 9 (33) A resident senior yearly license to fish, three dollars (\$3).
- 10 This license is subject to the following:
- 11 (A) An applicant must be at least sixty-four (64) years of age
- 12 and born after March 31, 1943.
- 13 (B) The license is in lieu of the resident yearly license to fish
- 14 and all other yearly licenses, stamps, or permits to fish for a
- 15 specific species or by a specific means.
- 16 (34) A resident senior "fish for life" license, seventeen dollars
- 17 (\$17). This license is subject to the following:
- 18 (A) An applicant must be at least sixty-four (64) years of age
- 19 and must have been born after March 31, 1943.
- 20 (B) The license applies each year for the remainder of the
- 21 license holder's life.
- 22 (C) The license is in lieu of the resident senior yearly license
- 23 to fish and all other yearly licenses, stamps, or permits to fish
- 24 for a specific species or by a specific means.
- 25 (35) A voluntary resident senior yearly license to fish, three
- 26 dollars (\$3). This license is subject to the following:
- 27 (A) An applicant must have been born before April 1, 1943.
- 28 (B) The license is instead of the resident yearly license to fish
- 29 and all other yearly licenses, stamps, and permits to fish for a
- 30 specific species or by a specific means.
- 31 (b) The commission may set license fees to hunt, trap, or fish above
- 32 the minimum fees established under subsection (a)
- 33 (c) **In addition to the license fees set under this section, the**
- 34 **department shall establish a procedure to collect voluntary**
- 35 **donations for processing wild game when a hunting license is sold.**
- 36 **The minimum suggested donation must be one dollar (\$1). The**
- 37 **money collected under this section shall be deposited in the Indiana**
- 38 **sportsmen's benevolence account (IC 14-9-5-4).**
