**MADAM PRESIDENT:**

**I move** that Engrossed House Bill 1086 be amended to read as follows:

- 1 Page 2, line 38, after "government," insert "**and**".
- 2 Page 2, line 39, delete ", and state educational institutions." and
- 3 insert ".".
- 4 Page 2, line 40, delete "office of management and" and insert
- 5 "**auditor of state**".
- 6 Page 2, line 41, delete "budget".
- 7 Page 2, line 41, delete "with the office of technology established"
- 8 and insert "**through the state board of finance**".
- 9 Page 2, line 42, delete "by IC 4-13.1-2-1".
- 10 Page 2, line 42, delete "establish and post on the Internet" and insert
- 11 "**design**".
- 12 Page 3, line 1, delete "account" and insert "**fund**".
- 13 Page 3, delete lines 3 through 5, begin a new paragraph and insert:
- 14 "**Sec. 3. The state and state officials, officers, and employees are**
- 15 **immune from any civil liability for posting confidential**
- 16 **information, including confidential personal information, if the**
- 17 **state or the state officials, officers, or employees posted the**
- 18 **information in reliance on a determination made by a state agency**
- 19 **about the confidentiality of information relating to the agency's**
- 20 **expenditures or fund balances.**".

- 22 Page 3, line 7, delete "management and budget".
- 23 Page 3, line 10, delete "office of management and" and insert
- 24 "**auditor of state**".
- 25 Page 3, line 11, delete "budget".
- 26 Page 11, delete lines 21 through 42.
- 27 Page 12, delete lines 1 through 11.
- 28 Page 12, delete lines 38 through 42.
- 29 Page 13, delete lines 1 through 24.
- 30 Page 23, between lines 26 and 27, begin a new paragraph and insert:

- 1 "SECTION 20. IC 6-3.1-13-10 IS AMENDED TO READ AS  
2 FOLLOWS [EFFECTIVE JANUARY 1, 2010 (RETROACTIVE)]:  
3 Sec. 10. As used in this chapter, "taxpayer" means a person,  
4 corporation, partnership, or other entity that has any state tax liability  
5 **or that submits incremental income tax withholdings under**  
6 **IC 6-3-4-8."**
- 7 Page 43, line 38, delete "IC 5-14-3.5-5" and insert "**IC 5-14-3.5-3**".
- 8 Page 43, line 39, delete "auditor of state and employees of the  
9 auditor of" and insert "**state and state officials, officers, and**  
10 **employees**".
- 11 Page 43, line 40, delete "state".
- 12 Page 46, between lines 14 and 15, begin a new paragraph and insert:  
13 "SECTION 43. IC 6-3.1-13-27 IS REPEALED [EFFECTIVE  
14 JANUARY 1, 2010 (RETROACTIVE)]."
- 15 Page 49, line 37, delete "person (as" and insert "**women's**  
16 **fraternity**".
- 17 Page 49, delete line 38.
- 18 Page 50, line 19, after "educational" insert "**or charitable**".
- 19 Renumber all SECTIONS consecutively.
