If agreed to by the second general assembly, the amendment must be placed on the state election ballot and ratified by a majority of the voters.**

IC 1-1-3.1-4(d) provides that if a provision of the act takes effect on a specified date and approval of the act occurs after the specified date the provision takes effect on July 1 next following approval of the act.*
