I move that Engrossed Senate Bill 105 be amended to read as follows:

- 1 Page 5, between lines 30 and 31, begin a new paragraph and insert:
2 "SECTION 4. IC 6-1.1-20.3-1.5 IS ADDED TO THE INDIANA
3 CODE AS A **NEW** SECTION TO READ AS FOLLOWS
4 [EFFECTIVE JULY 1, 2011]: **Sec. 1.5. As used in this chapter,**
5 **"commission" means a financial planning and supervision**
6 **commission for a distressed political subdivision established under**
7 **section 7.5 of this chapter."**
8 Page 9, delete lines 25 through 36, begin a new paragraph and
9 insert:
10 "SECTION 10. IC 6-1.1-20.3-7.5 IS ADDED TO THE INDIANA
11 CODE AS A **NEW** SECTION TO READ AS FOLLOWS
12 [EFFECTIVE JULY 1, 2011]: **Sec. 7.5. (a) If the board designates a**
13 **political subdivision as a distressed political subdivision under**
14 **section 6.5 of this chapter, the board shall establish a financial**
15 **planning and supervision commission for the distressed political**
16 **subdivision.**
17 **(b) A financial planning and supervision commission for a**
18 **distressed political subdivision consists of the following eleven (11)**
19 **members:**
20 (1) **The governor.**
21 (2) **The auditor of state.**
22 (3) **The treasurer of state.**
23 (4) **The commissioner of the department of state revenue.**
24 (5) **The executive director of the Indiana bond bank.**

- 1 (6) The public finance director of the Indiana finance
2 authority.
- 3 (7) The president of the Indiana economic development
4 corporation.
- 5 (8) The presiding officer of the fiscal body of the distressed
6 political subdivision.
- 7 (9) Three (3) members appointed by the board from a list of
8 five (5) individuals nominated in writing by the fiscal body
9 and the executive of the distressed political subdivision.
- 10 (c) A member of a commission listed in subsection (b)(1)
11 through (b)(8) may designate an individual to serve in the
12 member's place on the commission. A member listed in subsection
13 (b)(1) through (b)(8) shall make a designation to the board in
14 writing. A member listed in subsection (b)(1) through (b)(8) may
15 change the member's designee from time to time, but the member
16 shall give due regard to the need for continuity.
- 17 (d) The board shall appoint a chairman of a commission for a
18 distressed political subdivision when the commission is established.
- 19 (e) Each member of a commission for a distressed political
20 subdivision who is not a state employee or an employee of a
21 political subdivision is entitled to receive both of the following:
- 22 (1) The minimum salary per diem provided by
23 IC 4-10-11-2.1(b).
- 24 (2) Reimbursement for travel expenses and other expenses
25 actually incurred in connection with the member's duties, as
26 provided in the state travel policies and procedures
27 established by the Indiana department of administration and
28 approved by the budget agency.
- 29 (f) Each member of a commission for a distressed political
30 subdivision who is a state employee or an employee of a political
31 subdivision is entitled to reimbursement for travel expenses and
32 other expenses actually incurred in connection with the member's
33 duties, as provided in the state travel policies and procedures
34 established by the Indiana department of administration and
35 approved by the budget agency."

37 **commission for**".
- 38 Page 9, line 41, delete "appointed" and insert "**established**".
- 39 Page 10, line 6, delete "emergency manager" and insert
