I move that Engrossed Senate Bill 217 be amended to read as follows:

- 1 Delete the title and insert the following:
- 2 A BILL FOR AN ACT to amend the Indiana Code concerning state
- 3 and local administration and to make an appropriation.
- 4 Page 1, between the enacting clause and line 1, begin a new
- 5 paragraph and insert:
- 6 "SECTION 1. IC 20-43-2-2, AS AMENDED BY P.L.182-2009(ss),
- 7 SECTION 329, IS AMENDED TO READ AS FOLLOWS
- 8 [EFFECTIVE JANUARY 1, 2011 (RETROACTIVE)]; Sec. 2. The
- 9 maximum state distribution for a calendar year for all school
- 10 corporations for the purposes described in section 3 of this chapter is:
- 11 ~~(1) five billion eight hundred twenty-nine million nine hundred~~
- 12 ~~thousand dollars (\$5,829,900,000) in 2009;~~
- 13 ~~(2) six billion five hundred forty-eight million nine hundred~~
- 14 ~~thousand dollars (\$6,548,900,000) in 2010; and~~
- 15 ~~(3) (1) six billion five two hundred sixty-eight forty-seven~~
- 16 ~~million five seven hundred thousand dollars (\$6,568,500,000)~~

- 22 Page 2, after line 7, begin a new paragraph and insert:
- 23 "SECTION 3. [EFFECTIVE JULY 1, 2011] (a) **Notwithstanding**
- 24 **the appropriation made by HEA 1001-2011, SECTION 9 for**

1 full-day kindergarten, the amount appropriated for total operating  
2 expense for full-day kindergarten is as follows:

3 (1) For the state fiscal year beginning July 1, 2011, and ending  
4 June 30, 2012, one hundred fifty million dollars  
5 (\$150,000,000).

6 (2) For the state fiscal year beginning July 1, 2012, and ending  
7 June 30, 2013, one hundred fifty million dollars  
8 (\$150,000,000).

9 Except as provided by this subsection, HEA 1001-2011, SECTION  
10 9 applies to the appropriation for full-day kindergarten.

11 (b) Notwithstanding the appropriation made by HEA  
12 1001-2011, SECTION 9 for the distribution for tuition support, the  
13 amount appropriated for total operating expense for distribution  
14 for tuition support is as follows:

15 (1) For the state fiscal year beginning July 1, 2011, and ending  
16 June 30, 2012, six billion three hundred thirty-four million  
17 two hundred fifty thousand dollars (\$6,334,250,000).

18 (2) For the state fiscal year beginning July 1, 2012, and ending  
19 June 30, 2013, six billion four hundred twenty million eight  
20 hundred thousand dollars (\$6,420,800,000).

21 Except as provided by this subsection, HEA 1001-2011, SECTION  
22 9 applies to the appropriation for the distribution for tuition  
23 support.

24 (c) This SECTION expires December 31, 2013.  
25 SECTION 4. An emergency is declared for this act."  
26 Renumber all SECTIONS consecutively.
