- 24 [EFFECTIVE JULY 1, 2011]: **Sec. 3.5. (a) In addition to the**

1 requirements of sections 1 and 2 of this chapter, a public-private
 2 agreement must include provisions that require that not less than
 3 five percent (5%) of the total amount of money to be paid under
 4 the agreement be used for each of the following types of businesses:

 26 owned business" means a business concern owned and controlled by
 27 one (1) or more persons who are service disabled veterans.

28 SECTION 16. IC 8-15.7-2-23 IS ADDED TO THE INDIANA
 29 CODE AS A NEW SECTION TO READ AS FOLLOWS
 30 [EFFECTIVE JULY 1, 2011]: Sec. 23. "Women's business
 31 enterprise" means a businesses certified under IC 4-13-16.5 as a
 32 women's business enterprise."

33 Page 13, between lines 7 and 8, begin a new paragraph and insert:

34 "SECTION 21. IC 8-15.7-5-1.7 IS ADDED TO THE INDIANA
 35 CODE AS A NEW SECTION TO READ AS FOLLOWS
 36 [EFFECTIVE JULY 1, 2011]: Sec. 1.7. (a) In addition to the
 37 requirements of sections 1 and 2 of this chapter, a public-private
 38 agreement must include provisions that require that not less than
 39 five percent (5%) of the total amount of money to be paid under
 40 the agreement be used for each of the following types of businesses:

- 41 (1) Minority business enterprises.
- 42 (2) Women's business enterprises.
- 43 (3) Service disabled veteran owned businesses.

44 (b) If it is not possible to meet the requirements in subsection
 45 (a), the department must specify in writing the process used to
 46 attempt to meet the requirements of this section and the reasons it
