16 SECTION 15. [EFFECTIVE JULY 1, 2011] **(a) The legislative**

18 **2012 general assembly to make any necessary amendments to the**
19 **Indiana Code to carry out this act.**
20 **(b) This SECTION expires June 30, 2012."**
