HOUSE MOTION _____

MR. SPEAKER:

I move that House Bill 1006 be amended to read as follows:

- 1 Page 6, between lines 33 and 34, begin a new paragraph and insert:
- 2 "SECTION 5. IC 5-28-23-1, AS AMENDED BY P.L.2-2007,
- 3 SECTION 110, IS AMENDED TO READ AS FOLLOWS
- 4 [EFFECTIVE UPON PASSAGE]: Sec. 1. (a) The corporation shall do
- 5 the following:
- 6 (1) Contribute to the strengthening of the economy of Indiana
- 7 through the development of science and technology and to
- 8 promote the modernization of Indiana businesses by supporting
- 9 the transfer of science, technology, and quality improvement
- 10 methods to the workplace.
- 11 **(2) Encourage collaborative efforts between any of Indiana's**
- 12 **postsecondary educational institutions, local economic**
- 13 **development commissions, and businesses to customize job**
- 14 **training programs at postsecondary educational institutions**
- 15 **to encourage employment in high technology business**
- 16 **operations (as defined in IC 5-28-15-1).**
- 17 ~~(2)~~ **(3)** Submit an annual report to the governor and to the general
- 18 assembly (in an electronic format under IC 5-14-6) that is due on
- 19 the first day of November for each year and must include detailed
- 20 information on the corporation's efforts to carry out this chapter.
- 21 The corporation shall conduct an annual public hearing to receive
- 22 comments from interested parties regarding the report, and notice
- 23 of the hearing shall be given at least fourteen (14) days before the
- 24 hearing in accordance with IC 5-14-1.5-5(b).

- 1 (b) The corporation may do the following:
- 2 (1) Receive money from any source, borrow money, enter into
- 3 contracts, and expend money for activities appropriate to its
- 4 purpose under this chapter.
- 5 (2) Do things necessary or incidental to carrying out the functions
- 6 listed in this chapter.
- 7 (3) Establish a statewide business modernization network to assist
- 8 Indiana businesses in identifying ways to increase productivity
- 9 and market competitiveness.
- 10 (4) Identify scientific and technological problems and
- 11 opportunities related to the economy of Indiana and formulate
- 12 proposals to overcome those problems or realize those
- 13 opportunities.
- 14 (5) Identify specific areas in which scientific research and
- 15 technological investigation will contribute to the improvement of
- 16 productivity of Indiana manufacturers and farmers.
- 17 (6) Determine specific areas in which financial investment in
- 18 scientific and technological research and development from
- 19 private businesses located in Indiana could be improved or
- 20 increased if state resources were made available to assist in
- 21 financing activities.
- 22 (7) Assist in establishing cooperative associations of
- 23 postsecondary educational institutions in Indiana and of private
- 24 enterprises to coordinate research and development programs that
- 25 will, consistent with the primary educational function of the
- 26 postsecondary educational institutions, aid in the creation of new
- 27 jobs in Indiana.
- 28 (8) Assist in financing the establishment and continued
- 29 development of technology intensive businesses in Indiana.
- 30 (9) Advise postsecondary educational institutions of the research
- 31 needs of Indiana businesses and improve the exchange of
- 32 scientific and technological information for the mutual benefit of
- 33 postsecondary educational institutions and private businesses.
- 34 (10) Coordinate programs established by postsecondary
- 35 educational institutions to provide Indiana businesses with
- 36 scientific and technological information.
- 37 (11) Establish programs in scientific education that will support
- 38 the accelerated development of technology intensive businesses
- 39 in Indiana.
- 40 (12) Provide financial assistance through contracts, grants, and
- 41 loans to programs of scientific and technological research and
- 42 development.
- 43 (13) Determine how state educational institutions can increase
- 44 income derived from the sale or licensure of products or processes
- 45 having commercial value that are developed as a result of state
- 46 educational institution sponsored research programs."

- 1 Page 7, after line 20, begin a new paragraph and insert:
- 2 "SECTION 8. **An emergency is declared for this act.**".
- 3 Renumber all SECTIONS consecutively.
