

COMMITTEE REPORT

MADAM PRESIDENT:

The Senate Committee on Education and Career Development, to which was referred Senate Bill No. 482, has had the same under consideration and begs leave to report the same back to the Senate with the recommendation that said bill be AMENDED as follows:

- 1 Page 2, between lines 32 and 33, begin a new paragraph and insert:
2 "SECTION 4. IC 20-19-2-4.5 IS ADDED TO THE INDIANA
3 CODE AS A **NEW** SECTION TO READ AS FOLLOWS
4 [EFFECTIVE UPON PASSAGE]: **Sec. 4.5. (a) The advisory**
5 **committee on career and technical education is established to**
6 **advise the state board on policy matters concerning career and**
7 **technical education. The advisory committee on career and**
8 **technical education consists of:**
9 **(1) the state superintendent or the state superintendent's**
10 **designee; and**
11 **(2) seven (7) members appointed by the state superintendent.**
12 **(b) The following provisions apply to members of the advisory**
13 **committee on career and technical education:**
14 **(1) At least four (4) of the members must be actively employed**
15 **as area career and technical education directors in schools in**
16 **Indiana and hold a valid career and technical education**
17 **director license.**
18 **(2) Not more than one (1) member may be from any**
19 **secondary area district in Indiana.**
20 **(3) Members serve at the pleasure of the state superintendent.**
21 **(c) The state superintendent or the state superintendent's**

1 **designee serves as the chairperson of the advisory committee on**
2 **career and technical education."**

3 Page 16, between lines 3 and 4, begin a new paragraph and insert:

4 "SECTION 17. IC 22-4-18.1-5, AS AMENDED BY P.L.161-2006,
5 SECTION 10, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
6 UPON PASSAGE]: Sec. 5. (a) Subject to ~~subsection~~ **subsections** (b)
7 **and (c)**, the membership of the state workforce innovation council
8 established under section 3 of this chapter consists of the
9 representatives required by the Workforce Investment Act (29 U.S.C.
10 2801 et seq.), including reauthorizations of the Act, and must represent
11 the diverse regions of Indiana.

12 (b) The state superintendent of public instruction or the
13 superintendent's designee serves as a member of the state workforce
14 innovation council.

15 **(c) An individual designated by the governor who has been**
16 **nominated by a recognized adult education organization serves as**
17 **a member of the state workforce innovation council."**

18 Renumber all SECTIONS consecutively.
(Reference is to SB 482 as introduced.)
