MR. SPEAKER:

I move that Engrossed Senate Bill 179 be amended to read as follows:

- 1 Page 1, line 5, after "a" delete "provider" and insert "**public school,**
- 2 **charter school, or state educational institution**".
- 3 Page 1, line 7, delete "teachers" and insert "**teachers:**
- 4 **(1)**".
- 5 Page 1, line 9, delete "IC 20-26-2-1.5)." and insert
- 6 "**IC 20-26-2-1.5)**;
- 7 **(2) are residents of Indiana;**
- 8 **(3) are licensed to teach in Indiana;**
- 9 **(4) have each achieved a highly effective rating; and**
- 10 **(5) are qualified to teach:**
- 11 **(A) in the specific subject area of the course; and**
- 12 **(B) for the grade level of the course;**
- 13 **as shown by the credentials held by each teacher.**".
- 14 Page 1, between lines 13 and 14, begin a new line block indented
- 15 and insert:
- 16 "**(3) A nonpublic school accredited under IC 20-19-2-8.**
- 17 **(4) A school that participates in the choice scholarship**
- 18 **program under IC 20-51-4.**".
- 19 Page 2, line 8, delete "a" and insert "**if a student's parent or legal**
- 20 **guardian provides consent the**".
- 21 Page 2, line 12, delete "three (3)" and insert "**one (1)**".
- 22 Page 2, line 13, delete "courses" and insert "**course**".
- 23 Page 2, line 17, after "IC 20-31-5." insert "**The school corporation**
- 24 **may not offer:**

- 1           **(1) physical education courses;**
  - 2           **(2) courses that have a lab component;**
  - 3           **(3) vocational education courses; or**
  - 4           **(4) courses that utilize applied learning**
  - 5           **as a virtual instruction course under this chapter."**
  - 6           Page 3, between lines 27 and 28, begin a new line block indented
  - 7           and insert:
  - 8           **"(6) The establishment of pupil/teacher ratio requirements.**
  - 9           **(7) Establishing standards for virtual instruction courses that**
  - 10           **ensure:**
  - 11           **(A) the academic integrity of the courses; and**
  - 12           **(B) the alignment of the courses with Indiana academic**
  - 13           **standards."**
