MR. SPEAKER:

I move that Engrossed Senate Bill 179 be amended to read as follows:

- 1 Page 1, between the enacting clause and line 1, begin a new
- 2 paragraph and insert:
- 3 "SECTION 1. IC 20-19-3-11 IS ADDED TO THE INDIANA CODE
- 4 AS A **NEW** SECTION TO READ AS FOLLOWS [EFFECTIVE JULY
- 5 1, 2012]: **Sec. 11. In each state fiscal year beginning after June 30,**
- 6 **2012, the department shall dedicate out of money appropriated to**
- 7 **the department for the operation, maintenance, and support of the**
- 8 **department two hundred fifty thousand dollars (\$250,000) to fund**
- 9 **the teach for Indiana scholarship under IC 21-13-7 and shall**
- 10 **deposit that amount into the teach for Indiana scholarship fund**
- 11 **established by IC 21-13-7-1."**
- 12 Page 3, between lines 27 and 28, begin a new paragraph and insert:
- 13 "SECTION 3. IC 21-13-1-2.5 IS ADDED TO THE INDIANA
- 14 CODE AS A **NEW** SECTION TO READ AS FOLLOWS
- 15 [EFFECTIVE JULY 1, 2012]: **Sec. 2.5. "Department" refers to the**
- 16 **department of education established by IC 20-19-3-1.**
- 17 SECTION 4. IC 21-13-1-5, AS AMENDED BY P.L.170-2009,
- 18 SECTION 3, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
- 19 JULY 1, 2012]: **Sec. 5. "Fund":**
- 20 (1) for purposes of IC 21-13-2, refers to the minority teacher or
- 21 special education services scholarship fund established by
- 22 IC 21-13-2-1;
- 23 (2) for purposes of IC 21-13-3, refers to the nursing scholarship
- 24 fund established by IC 21-13-3-1;

- 1 (3) for purposes of IC 21-13-4, refers to the National Guard
 2 tuition supplement program fund established by IC 21-13-4-1;
 3 (4) for purposes of IC 21-13-5, refers to the National Guard
 4 scholarship extension fund established by IC 21-13-5-1; and
 5 (5) for purposes of IC 21-13-6, refers to the primary care
 6 physician loan forgiveness fund established by IC 21-13-6-3; and
 7 **(6) for purposes of IC 21-13-7, refers to the teach for Indiana
 8 scholarship fund established by IC 21-13-7-1.**

9 SECTION 5. IC 21-13-7 IS ADDED TO THE INDIANA CODE AS
 10 A NEW CHAPTER TO READ AS FOLLOWS [EFFECTIVE JULY
 11 1, 2012]:

12 **Chapter 7. Teach for Indiana Scholarship Fund**

13 **Sec. 1. (a) The teach for Indiana scholarship fund (referred to**
 14 **as "the fund" in this chapter) is established to encourage qualified**
 15 **individuals to pursue a career in teaching in a school that:**

- 16 (1) has a high concentration of low income students; or
 17 (2) has been placed in the lowest category or designation
 18 under IC 20-31-8-4.

19 **(b) The fund consists of:**

- 20 (1) money deposited into the fund under IC 20-19-3-11; and
 21 (2) gifts.

22 **Sec. 2. (a) The commission shall administer the fund.**

23 **(b) The expenses of administering the fund shall be paid from**
 24 **money in the fund.**

25 **(c) The treasurer of state shall invest the money in the fund not**
 26 **currently needed to meet the obligations of the fund in the same**
 27 **manner as other public funds may be invested. Interest that**
 28 **accrues from those investments must be deposited in the fund.**

29 **(d) Money in the fund at the end of a state fiscal year does not**
 30 **revert to the state general fund but remains available to provide**
 31 **money for scholarships under this chapter.**

32 **Sec. 3. The commission shall use the money in the fund to**
 33 **provide annual scholarships to students who qualify by**
 34 **demonstrating a financial need and meeting the requirements set**
 35 **forth in this chapter. An annual scholarship awarded under this**
 36 **chapter is equal to the lesser of the following amounts:**

- 37 (1) The total cost incurred by the student for tuition and fees
 38 in attending an eligible institution for the academic year.
 39 (2) Twenty-five thousand dollars (\$25,000).

40 **Sec. 4. A scholarship awarded under this chapter may be used**
 41 **only for the payment of educational costs that are:**

- 42 (1) approved by the commission; and
 43 (2) not otherwise payable under any other scholarship or form
 44 of financial assistance specifically designated for educational
 45 costs.

46 **Sec. 5. A student may apply to the commission for a scholarship**
 47 **under this chapter. To initially qualify for a scholarship from the**

1 **fund, the student must:**

2 **(1) be admitted to an eligible institution as a full-time student**
 3 **or already attending an eligible institution as a full-time**
 4 **student;**

5 **(2) be ranked in the top twenty-five percent (25%) of the class**
 6 **with which the student graduated from secondary school (as**
 7 **defined in IC 20-18-2-18), as certified by the school**
 8 **corporation or by the private secondary school attended by**
 9 **the student;**

10 **(3) either:**

11 **(A) intend to pursue; or**

12 **(B) in the case of a student who is already attending an**
 13 **eligible institution, be pursuing;**

14 **a course of study that would enable the student, upon**
 15 **graduation, to teach in an accredited school in Indiana; and**

16 **(4) agree, in writing, to teach in a public school (not including**
 17 **a charter school) in Indiana that:**

18 **(A) has a high concentration of low income students; or**

19 **(B) has been placed in the lowest category or designation**
 20 **under IC 20-31-8-4, as determined by the department**
 21 **under section 8 of this chapter;**

22 **for at least three (3) years of the first five (5) years after the**
 23 **student's certification as a teacher.**

24 **Sec. 6. Subject to the requirements set forth in sections 5 and 7**
 25 **of this chapter, a scholarship under this chapter may be renewed**
 26 **for a total number of terms that does not exceed:**

27 **(1) eight (8) full-time (or part-time equivalent) semesters; or**

28 **(2) twelve (12) full-time (or part-time equivalent) semesters.**

29 **However, the commission may not grant a scholarship renewal to**
 30 **a student for an academic year that ends later than six (6) years**
 31 **after the date the student received the initial scholarship under this**
 32 **chapter.**

33 **Sec. 7. (a) Except as provided in subsection (b), to qualify for**
 34 **renewal of a scholarship under this chapter, a student who**
 35 **qualified for the initial scholarship under section 5 of this chapter**
 36 **must maintain at least the following cumulative grade point**
 37 **averages:**

38 **(1) For credit hours applicable to the equivalent of the**
 39 **student's freshman academic year, a cumulative grade point**
 40 **average that the eligible institution determines to constitute**
 41 **satisfactory academic progress.**

42 **(2) For credit hours applicable to the equivalent of the**
 43 **student's sophomore academic year, a cumulative grade point**
 44 **average of 2.25 on a 4.0 grading scale or an equivalent grade**
 45 **point average as established by the eligible institution.**

46 **(3) For credit hours applicable to the equivalent of the**
 47 **student's junior or senior academic year, a cumulative grade**

1 point average of 2.5 on a 4.0 grading scale or an equivalent
 2 grade point average as established by the eligible institution.
 3 (b) The commission may waive a cumulative grade point
 4 average requirement set forth in subsection (a) for a student if the
 5 commission determines that extenuating circumstances prevented
 6 the student from achieving the required cumulative grade point
 7 average. However, the commission may not waive a cumulative
 8 grade point average requirement set forth in subsection (a) for a
 9 student for more than one (1) academic year.

10 Sec. 8. (a) The department shall develop and maintain a list of
 11 public schools (not including charter schools) that:
 12 (1) have a high concentration of low income students; or
 13 (2) have been placed in the lowest category or designation
 14 under IC 20-31-8-4;
 15 and that the department recommends for purposes of the
 16 agreement described in section 5(4) of this chapter.
 17 (b) The department shall annually provide a copy of the list of
 18 schools maintained under subsection (a) to the commission.

19 Sec. 9. (a) The commission, in administering the fund and
 20 awarding scholarships under this chapter, shall maintain complete
 21 and accurate records, including records of the following:
 22 (1) The number of scholarships awarded under this chapter.
 23 (2) The number of individuals who fulfilled the agreement
 24 described in section 5(4) of this chapter.
 25 (3) The number of individuals who did not fulfill the
 26 agreement described in section 5(4) of this chapter.
 27 (b) Each eligible institution shall provide the commission with
 28 information concerning the following:
 29 (1) The academic progress made by each recipient of a
 30 scholarship under this chapter who attends the eligible
 31 institution.
 32 (2) Other pertinent information requested by the
 33 commission."
 34 Renumber all SECTIONS consecutively.
