MR. SPEAKER:

I move that Engrossed Senate Bill 286 be amended to read as follows:

- 1 Delete the title and insert the following:
2 A BILL FOR AN ACT to amend the Indiana Code concerning
3 family law and juvenile law and to make an appropriation.
4 Page 33, line 15, after "." insert "**Before January 1, 2013, each**
5 **county must be included in a region established under this**
6 **section.**".
7 Page 35, between lines 31 and 32, begin a new line block indented
8 and insert:
9 "**(14) A member appointed by the legislative body of each**
10 **county included in the region served by the local child fatality**
11 **review team.**".
12 Page 62, between lines 22 and 23, begin a new paragraph and insert:
13 "SECTION 72. [EFFECTIVE JULY 1, 2012] **(a) The definitions in**
14 **P.L.229-2011, SECTION 1 apply throughout this SECTION.**
15 **(b) As used in this SECTION, "department" means the**
16 **department of child services.**
17 **(c) Augmentation is allowed for the appropriation in**
18 **P.L.229-2011, SECTION 8 to the department of child services,**
19 **beginning July 1, 2012, and ending June 30, 2013. The**
20 **appropriation is augmented by one million dollars (\$1,000,000) for**
21 **the following purposes:**
22 **(1) Five hundred thousand dollars (\$500,000) for the use of**
23 **the state child fatality review team to carry out its duties**

- 1 **under IC 31-33-25.**
- 2 **(2) Five hundred thousand dollars (\$500,000) for carrying out**
- 3 **the grant program established under subsection (d).**
- 4 **(d) The department shall establish a grant program to assist**
- 5 **regional child fatality review teams. A regional child fatality**
- 6 **review team may apply for a grant in the manner prescribed by the**
- 7 **department. The department shall record the time of filing of each**
- 8 **application and shall, except as provided in subsection (e), award**
- 9 **grants to regional child fatality review teams in the chronological**
- 10 **order in which the applications were filed. The total amount**
- 11 **awarded to a particular regional child fatality review team may**
- 12 **not exceed five thousand dollars (\$5,000) per county included in the**
- 13 **region served by the regional child fatality review team.**
- 14 **(e) The total amount of the grants awarded under this**
- 15 **SECTION may not exceed four hundred sixty thousand dollars**
- 16 **(\$460,000). The department may not approve an application filed**
- 17 **after the maximum amount of grants has been awarded.**
- 18 **(f) A regional child fatality review team may use a grant**
- 19 **received under this SECTION for any lawful purpose of the**
- 20 **regional child fatality review team.**
- 21 **(g) This SECTION expires June 30, 2013."**
- 22 Renumber all SECTIONS consecutively.
