4 **UPON PASSAGE]: Sec. 8. Not later than December 31, 2012, the**
5 **department shall ensure that in every county in Indiana homes or**
6 **facilities exist that can accept emergency placements of children**
7 **under this chapter.**
8 SECTION 54. IC 31-34-4-9 IS ADDED TO THE INDIANA CODE
9 AS A **NEW SECTION TO READ AS FOLLOWS [EFFECTIVE JULY**
10 **1, 2012]: Sec. 9. (a) The department may not decrease rates paid to**
11 **a home or facility under this chapter without approval of the**
12 **general assembly.**
13 **(b) The department shall ensure that there is adequate funding**
14 **for homes and facilities under this chapter."**
15 Page 56, between lines 34 and 35, begin a new paragraph and insert:
16 "SECTION 68. IC 31-37-5-9 IS ADDED TO THE INDIANA CODE
17 AS A **NEW SECTION TO READ AS FOLLOWS [EFFECTIVE**
18 **UPON PASSAGE]: Sec. 9. Not later than December 31, 2012, the**
19 **department shall ensure that in every county in Indiana homes or**
20 **facilities exist that can accept emergency placements of children**
21 **under this chapter.**
22 SECTION 69. IC 31-37-5-10 IS ADDED TO THE INDIANA
23 CODE AS A **NEW SECTION TO READ AS FOLLOWS**
24 **[EFFECTIVE UPON PASSAGE]: Sec. 10. (a) The department may**

1 not decrease rates paid to a home or facility under this chapter
 2 without approval of the general assembly.
 3 (b) The department shall ensure that there is adequate funding
 4 for homes and facilities under this chapter."
 5 Page 62, between lines 22 and 23, begin a new paragraph and insert:
 6 "SECTION 76. [EFFECTIVE UPON PASSAGE] The department
 7 of child services shall prepare a report concerning the following:
 8 (1) Listing by category the number of placements for children,
 9 including:
 10 (A) foster family homes;
 11 (B) group homes; and
 12 (C) other homes or facilities in which the department
 13 places children;
 14 in each county for the calendar years 2007, 2008, 2009, 2010,
 15 and 2011.
 16 (2) Listing by category, the amount of money that the
 17 department of child services has spent on:
 18 (A) foster family homes;
 19 (B) group homes; and
 20 (C) other homes or facilities in which the department
 21 places children;
 22 in each county for the calendar years 2007, 2008, 2009, 2010,
 23 and 2011."
 24 Renumber all SECTIONS consecutively.
