# HOUSE MOTION \_\_\_\_\_

MR. SPEAKER:

I move that Engrossed Senate Bill 384 be amended to read as follows:

- 1 Page 1, between the enacting clause and line 1, begin a new
- 2 paragraph and insert:
- 3 "SECTION 1. IC 20-19-2-2, AS ADDED BY P.L. 1-2005, SECTION
- 4 3, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE UPON
- 5 PASSAGE]: Sec. 2. (a) The Indiana state board of education is
- 6 established. The state board consists of:
- 7 (1) the state superintendent; and
- 8 (2) ten (10) members appointed **jointly** by the ~~governor~~
- 9 **president pro tempore of the senate, the speaker of the house**
- 10 **of representatives, the minority leader of the senate, and the**
- 11 **minority leader of the house of representatives.**
- 12 (b) The following provisions apply to members of the state board
- 13 appointed by the governor:
- 14 (1) At least four (4) of the members must be actively employed in
- 15 the schools in Indiana and hold a valid teaching license.
- 16 (2) At least one (1) member must be appointed from each
- 17 congressional district in Indiana.
- 18 (3) Not more than six (6) members of the state board may be
- 19 appointed from the membership of any one (1) political party.
- 20 (4) The term of office of a member begins on July 1. Except as
- 21 provided in subdivision (5), the term of office of a member is four
- 22 (4) years. **A member may not serve more than two (2) terms.**
- 23 (5) The ~~governor~~ **appointing authority** may dismiss a member
- 24 for just cause.

- 1           (6) The ~~governor~~ **appointing authority** may appoint a member to
- 2           fill a vacancy occurring on the state board. A member appointed
- 3           under this subdivision serves for the remainder of the unexpired
- 4           term.
- 5           (c) A quorum consists of six (6) members of the state board. An
- 6           action of the state board is not official unless the action is authorized
- 7           by at least six (6) members.
- 8           (d) The state superintendent serves as chairperson of the state board.
- 9           **(e) Notwithstanding subsection (b)(4), the term of a member**
- 10          **servng on June 30, 2012, expires July 1, 2012. A member serving**
- 11          **on June 30, 2012, may be appointed by the appointing authority for**
- 12          **a new term beginning July 1, 2012, unless the appointment would**
- 13          **cause the member to serve more than two (2) terms."**
- 14          Renumber all SECTIONS consecutively.
