*Your Committee on Public Health, to which was referred House Bill 1149, has had the same under consideration and begs leave to report the same back to the House with the recommendation that said bill **be amended** as follows:*

- 1 Page 1, between lines 4 and 5, begin a new paragraph and insert:
- 2 "Sec. 0.5. As used in this chapter, "ashtray" means any
- 3 receptacle that is used for disposing of smoking materials,
- 4 including ash and filters.
- 5 Sec. 1. As used in this chapter, "place of employment" means an
- 6 enclosed area of a structure that is a place of employment. The
- 7 term does not include a private vehicle."
- 8 Page 1, line 5, delete "1." and insert "2."
- 9 Page 1, line 7, delete "2." and insert "3."
- 10 Page 1, line 9, after "lighted" insert "tobacco".
- 11 Page 1, line 10, after "lighted" insert "tobacco".
- 12 Page 1, line 12, delete "3." and insert "4."
- 13 Page 1, line 12, delete "4" and insert "5".
- 14 Page 1, line 15, delete "Enclosed areas of a" and insert "A".

 16 **less than eighteen (18) years of age.**
 17 **(6) A retail tobacco store used primarily for the sale of**
 18 **tobacco products and accessories that, before February 3,**
 19 **2012, meets the following requirements:**
 20 **(A) The store has a valid tobacco sales certificate issued**
 21 **under IC 7.1-3-18.5.**
 22 **(B) The store prohibits entry by an individual who is less**
 23 **than eighteen (18) years of age.**
 24 **(C) The sale of products other than tobacco is merely**
 25 **incidental.**
 26 **(D) The sale of tobacco products accounts for at least**
 27 **eighty-five percent (85%) of the store's annual gross**
 28 **income.**
 29 **(E) Food or beverages are not sold for consumption on the**
 30 **premises, and there is not an area set aside for customers**
 31 **to consume food or beverages on the premises."**
