HOUSE BILL No. 1244



A BILL FOR AN ACT to amend the Indiana Code concerning education.

Be it enacted by the General Assembly of the State of Indiana:

1 SECTION 1. IC 20-51-4-12 IS ADDED TO THE INDIANA CODE
2 AS A **NEW SECTION** TO READ AS FOLLOWS [EFFECTIVE
3 UPON PASSAGE]: **Sec. 12. (a) State tuition support distributions**
4 **to school corporations and charter schools may not be reduced to**
5 **pay for choice scholarships distributed under this chapter.**
6 **(b) A determination under IC 4-13-2-18 or another law that the**
7 **amount available for choice scholarships under this chapter for the**
8 **remainder of the term of an appropriation or for any allotment**
9 **period will be less than the amount estimated or allotted therefore**
10 **may not be the basis for reducing state tuition support**
11 **distributions to school corporations and charter schools.**
12 **(c) The actions prohibited by this section include any of the**
13 **following that has the direct or indirect effect of making an amount**
14 **available for choice scholarships:**
15 **(1) Payment of or encumbering an amount of a choice**
16 **scholarship from a distribution for tuition support**
17 **appropriation.**



- 1 **(2) Transfer of, assignment of, or reassignment of an amount**
- 2 **from a distribution for tuition support appropriation to**
- 3 **another purpose.**
- 4 **(3) Reduction of the maximum state distribution for a**
- 5 **calendar year under IC 20-43-2-2, IC 20-43-2-3, or another**
- 6 **law.**
- 7 **(4) Withholding allotment of amounts that otherwise are**
- 8 **available for state tuition support distributions to school**
- 9 **corporations and charter schools.**
- 10 **SECTION 2. An emergency is declared for this act.**
