## HOUSE BILL No. 1247



A BILL FOR AN ACT to amend the Indiana Code concerning motor vehicles.

*Be it enacted by the General Assembly of the State of Indiana:*

1 SECTION 1. IC 9-24-12-1, AS AMENDED BY P.L.87-2010,  
2 SECTION 30, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE  
3 UPON PASSAGE]: Sec. 1. (a) **Notwithstanding subsection (c) and**  
4 **except as provided in subsections subsection (b) and (d) and section**  
5 **sections 10, 11, and 12** of this chapter, **the expiration date for a**  
6 **license and for the renewal of** an operator's license ~~issued under this~~  
7 ~~article before January 1, 2006; expires at midnight of the birthday of~~  
8 ~~the holder that occurs four (4) years following the date of issuance;~~  
9 **that contains a 2012 expiration date is as follows:**

10 (1) **If the license was issued after May 14, 2007, and before**  
11 **January 1, 2008, the license expires at midnight on the**  
12 **birthday of the holder that occurs five (5) years following the**  
13 **date of issuance.**

14 (2) **If the license was issued after December 31, 2007, and**  
15 **before January 1, 2009, the license expires at midnight on the**  
16 **birthday of the holder that occurs six (6) years following the**  
17 **date of issuance.**



1           **(3) If the license was issued after December 31, 2008, and**  
 2           **before May 14, 2010, the license expires at midnight on the**  
 3           **birthday of the holder that occurs four (4) years following the**  
 4           **date of issuance.**

5           **This subsection does not apply to the issuance or renewal of an**  
 6           **operator's license that contains an expiration date after 2012.**

7           (b) Except as provided in sections 10, 11, and 12 of this chapter, an  
 8           operator's license issued to an applicant who is at least seventy-five  
 9           (75) years of age expires at midnight of the birthday of the holder that  
 10          occurs three (3) years following the date of issuance.

11          (c) Except as provided in subsections **(a)**, **(b)**, ~~and~~ **(d)**, and **(f) and**  
 12          sections 10, 11, and 12 of this chapter, an operator's license issued  
 13          under this article expires at midnight of the birthday of the holder that  
 14          occurs six (6) years following the date of issuance.

15          (d) A probationary operator's license issued under IC 9-24-11-3  
 16          expires at midnight of the twenty-first birthday of the holder.

17          (e) A probationary **operator's** license issued under IC 9-24-11-3.3  
 18          to an individual who complies with IC 9-24-9-2.5(5) through  
 19          IC 9-24-9-2.5(9) expires:

20               (1) at midnight one (1) year after issuance if there is no expiration  
 21               date on the authorization granted to the individual to remain in the  
 22               United States; or

23               (2) if there is an expiration date on the authorization granted to  
 24               the individual to remain in the United States, the earlier of the  
 25               following:

26                       (A) At midnight of the date the authorization to remain in the  
 27                       United States expires.

28                       (B) At midnight of the date thirty (30) days after the  
 29                       twenty-first birthday of the holder.

30          (f) Except as provided in subsection (e), a probationary operator's  
 31          license issued under IC 9-24-11-3.3 expires at midnight of the date  
 32          thirty (30) days after the twenty-first birthday of the holder.

33          SECTION 2. IC 9-29-9-2, AS AMENDED BY P.L.101-2009,  
 34          SECTION 12, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE  
 35          UPON PASSAGE]: Sec. 2. (a) **Except as provided in subsection (c)**,  
 36          the fee for an operator's license issued under IC 9-24-3 or renewed  
 37          under IC 9-24-12 to an individual who is:

38               (1) less than seventy-five (75) years of age is nine dollars (\$9);  
 39               and

40               (2) at least seventy-five (75) years of age is six dollars (\$6).

41          (b) The fee for a probationary license issued under IC 9-24-11-3 or  
 42          IC 9-24-11-3.3 is six dollars (\$6).

1           (c) Notwithstanding subsection (a), the fee for the renewal of an  
2 operator's license issued under IC 9-24 that contains a 2012  
3 expiration date is as follows:  
4           (1) If the license was issued after May 14, 2007, and before  
5 January 1, 2008, the fee is seven dollars and fifty cents (\$7.50).  
6           (2) If the license was issued after December 31, 2007, and  
7 before January 1, 2009, the fee is nine dollars (\$9).  
8           (3) If the license was issued after December 31, 2008, and  
9 before May 14, 2010, the fee is six dollars (\$6).  
10       This subsection does not apply to the issuance or renewal of an  
11 operator's license that contains an expiration date after 2012.  
12       SECTION 3. An emergency is declared for this act.
