

SENATE MOTION

MADAM PRESIDENT:

I move that Engrossed House Bill 1280 be amended to read as follows:

- 1 Page 1, between the enacting clause and line 1, begin a new
2 paragraph and insert:
3 "SECTION 1. IC 2-5-21-10 IS AMENDED TO READ AS
4 FOLLOWS [EFFECTIVE JULY 1, 2012]: Sec. 10. (a) Subject to
5 subsection (c), the chairman of the council, with the advice of the vice
6 chairman of the council, shall appoint a committee to evaluate each of
7 the following:
8 **(1) Agencies and programs with commerce or economic**
9 **development matters as their major function during 2012.**
10 **The committee and the subcommittee shall include in the**
11 **evaluation under this subdivision all programs administered**
12 **by the Indiana economic development corporation**
13 **established by IC 5-28-3-1.**
14 ~~(1)~~ **(2) Agencies and programs with highway or transportation**
15 **matters as their major function during ~~1994~~ 2013.**
16 ~~(2)~~ **(3) Agencies and programs with occupational licensing as**
17 **their major function during ~~1995~~ 2014.**
18 ~~(3)~~ **Agencies and programs with commerce matters as their**
19 **major function during ~~1996~~.**
20 **(4) Agencies and programs with agricultural matters as their**
21 **major function during ~~1997~~ 2015.**
22 **(5) Agencies and programs with human resources or economic**
23 **security as their major function during ~~1998~~ 2016.**
24 **(6) Agencies and programs with management or administration**
25 **as their major function during ~~1999~~ 2017.**
26 **(7) Agencies and programs with corrections or judicial matters**
27 **as their major function during ~~2000~~ 2018.**
28 **(8) Agencies and programs with public safety matters as their**
29 **major function during ~~2001~~ 2019.**
30 **(9) Agencies and programs with education matters as their major**
31 **function during ~~2002~~ 2020.**
32 **(10) Agencies and programs with human services as their major**

- 1 function during ~~2003~~: **2021**.
- 2 (11) Agencies and programs with labor matters as their major
- 3 function during ~~2004~~: **2022**.
- 4 (12) Agencies and programs with taxation or finance as their
- 5 major function during ~~2005~~: **2023**.
- 6 (13) Agencies and programs with business regulation as their
- 7 major function during ~~2006~~: **2024**.
- 8 (14) Agencies and programs with health matters as their major
- 9 function during ~~2007~~: **2025**.
- 10 (15) Agencies and programs with natural resources or recreation
- 11 as their major function during ~~2008~~: **2026**.

12 (b) The committee shall be appointed before July 1 of the year the
13 agencies and programs are required to be evaluated under this section.

14 (c) The council by resolution may do any of the following with
15 respect to agencies and programs evaluated under this section:

- 16 (1) Require evaluation of agencies and programs in an order
- 17 different from the order specified in subsection (a).
- 18 (2) Assign specific topics or issues for audit and evaluation by
- 19 staff and a committee.
- 20 (3) Assign areas for audit and evaluation in classifications
- 21 different from the areas described in subsection (a).

22 SECTION 2. IC 2-5-21-14 IS AMENDED TO READ AS
23 FOLLOWS [EFFECTIVE JULY 1, 2012]: Sec. 14. **(a)** Subject to the
24 direction of the subcommittee, a committee shall do the following
25 during the year the committee is appointed to evaluate agencies and
26 programs:

- 27 (1) Review audit reports.
- 28 (2) Take testimony regarding audit reports and other areas the
- 29 committee considers related to the committee's work.
- 30 (3) Make recommendations for legislation.
- 31 (4) Make recommendations for administrative changes.

32 **(b) With respect to agencies and programs with commerce or**
33 **economic development matters as their major function, including**
34 **the Indiana economic development corporation established by**
35 **IC 5-28-3-1, the committee shall include with any recommendation**
36 **for legislation or administrative change, an estimate of the amount**
37 **of state fund savings that would result from implementing the**
38 **recommendation. If a recommendation results in savings to a state**
39 **fund, as determined by the budget agency, the amount of the**
40 **savings shall be transferred from the state fund to which the**
41 **savings are attributable to the capital access account, as defined in**
42 **IC 5-28-29-4."**
