

SENATE MOTION

MADAM PRESIDENT:

I move that Engrossed House Bill 1189 be amended to read as follows:

- 1 Replace the effective date in SECTION 10 with "[EFFECTIVE
- 2 JULY 1, 2012]".
- 3 Replace the effective date in SECTION 13 with "[EFFECTIVE
- 4 JULY 1, 2012]".
- 5 Replace the effective date in SECTION 15 with "[EFFECTIVE
- 6 JULY 1, 2012]".
- 7 Replace the effective date in SECTION 46 with "[EFFECTIVE
- 8 UPON PASSAGE]".
- 9 Replace the effective date in SECTION 72 with "[EFFECTIVE
- 10 JULY 1, 2012]".
- 11 Replace the effective dates in SECTIONS 74 through 75 with
- 12 "[EFFECTIVE JULY 1, 2012]".
- 13 Page 14, between lines 23 and 24, begin a new paragraph and insert:
- 14 "**(g) In the second six (6) months of calendar year 2012, a virtual**
- 15 **charter school is eligible to receive a fiscal year transition grant**
- 16 **under IC 20-43-13."**
- 17 Page 23, line 22, delete "corporation" and insert "**year**".
- 18 Page 23, line 24, delete "corporation" and insert "**year**".
- 19 Page 31, delete lines 16 through 23, begin a new line block indented
- 20 and insert:
- 21 "**(1) for previous state fiscal years ending before July 1, 2013,**
- 22 **the initial computed fall count of ADM; for the school year**
- 23 **ending in the preceding calendar year; and**
- 24 **(2) for previous state fiscal years ending after June 30, 2013,**
- 25 **the corresponding current ADM count taken in the same**
- 26 **month as the current count."**
- 27 Page 31, line 33, delete "January" and insert "**July**".
- 28 Page 31, line 36, delete "December" and insert "**June 30, 2013, the:**
- 29 **(A) fall count of ADM for distributions in the months of**
- 30 **January through June of the calendar year immediately**

- 1 following the calendar year in which the fall count is taken;
 2 and
 3 **(B) spring count of ADM for distributions in the months of**
 4 **July through December of the calendar year in which the**
 5 **spring count is taken."**

 7 Page 32, delete line 1.
 8 Page 32, line 7, delete "and" and insert "or".
 9 Page 34, line 10, delete "2012".
 10 Page 34, delete lines 12 through 13.
 11 Page 36, line 27, delete "spring" and insert "fall".
 12 Page 36, line 28, delete "fifteen" and insert "ten".
 13 Page 36, line 28, delete "(15%)." and insert "(10%).".
 14 Page 38, line 32, before "calendar" insert "following".
 15 Page 42, line 40, after "1." insert "(a)".
 16 Page 43, line 1, delete "The" and insert "Subject to subsections (b)
 17 and (c), the".
 18 Page 43, between lines 6 and 7, begin a new paragraph and insert:
 19 "**(b) Before February 1 of each calendar year, the department**
 20 **shall determine the result of:**
 21 **(1) the total amount of the special education grant that would**
 22 **have been received by the school corporation during the**
 23 **months of July, August, September, October, November, and**
 24 **December of the preceding calendar year and January of the**
 25 **current calendar year if the grant had been based on the**
 26 **count of students with disabilities that was made on the**
 27 **immediately preceding December 1; minus**
 28 **(2) the total amount of the special education grant received by**
 29 **the school corporation during the months of July, August,**
 30 **September, October, November, and December of the**
 31 **preceding calendar year and January of the current calendar**
 32 **year.**
 33 **If the result determined under this subsection is positive, the school**
 34 **corporation shall receive an additional special education grant**
 35 **distribution in February equal to the result determined under this**
 36 **subsection. If the result determined under this subsection is**
 37 **negative, the special education grant distributions that otherwise**
 38 **would be received by the school corporation in February, March,**
 39 **April, and May shall be proportionately reduced so that the total**
 40 **reduction is equal to the result determined under this subsection.**
 41 **(c) The special education grant distributions made in February,**
 42 **March, April, May, and June of a calendar year shall be based on**
 43 **the count of students with disabilities that was made on the**
 44 **immediately preceding December 1."**
 45 Page 48, line 21, after "corporations" delete "." and insert ",
 46 including virtual charter schools."

- 2 Page 54, between lines 15 and 16, begin a new line block indented
- 3 and insert:
- 4 **"(2) the number of students who left a public school**
- 5 **maintained by a school corporation and enrolled in a charter**
- 6 **school during the 2011 - 2012 school year;**
- 7 **(3) the number of students who:**
- 8 **(A) left a public school maintained by a school**
- 9 **corporation; and**
- 10 **(B) enrolled in a nonpublic eligible school (as defined in**
- 11 **IC 20-51-1-4.7) during the 2011 - 2012 school year; and".**
- 12 Page 54, line 16, delete "(2)" and insert "(4)".
- 13 Renumber all SECTIONS consecutively.
