- 3 Page 3, delete lines 1 through 2.
- 4 Page 3, line 3, delete "(6)" and insert "(5)".
- 5 Page 3, line 5, delete "February 3," and insert "**June 30,**".
- 6 Page 3, line 16, delete "the sale of either:" and insert ":".
- 7 Page 3, line 17, after "(i)" insert "**the sale of**".
- 8 Page 3, line 18, after "(ii)" insert "**the sale of**".
- 9 Page 3, line 22, delete "(7)" and insert "(6)".
- 10 Page 3, line 24, delete "February 3," and insert "**June 30,**".
- 11 Page 3, line 38, delete "(8)" and insert "(7)".
- 12 Page 3, line 39, delete "before February 3," and insert "**on June**

4 **requirements under subsection (b), the**".
- 5 Page 6, between lines 4 and 5, begin a new paragraph and insert:
6 "**(e) The division of fire and building safety may enforce this**
7 **chapter by filing a civil action under IC 22-12-7-13.**".
- 8 Page 6, line 13, delete "A person, owner, manager, or employer" and
9 insert "**An owner, a manager, or an employer**".
- 10 Page 6, line 30, delete "normal".
- 11 Page 7, delete lines 10 through 15.
- 12 Page 8, delete line 42.
