**The Senate Committee on Judiciary, to which was referred House Bill No. 1222, has had the same under consideration and begs leave to report the same back to the Senate with the recommendation that said bill be AMENDED as follows:**

- 1 Page 7, line 10, delete "IC 9-32-13," and insert "**IC 9-32-12**,".
- 2 Page 24, line 22, after "vehicle" insert "**sales**".
- 3 Page 24, line 26, delete "six (6)" and insert "**three (3)**".
- 4 Page 29, line 42, delete "3" and insert "**2**".
- 5 Page 31, line 21, delete "section 2(a)(5)(C)" and insert "**section**
- 6 **1(a)(5)(C)**".
- 7 Page 36, line 8, delete "vehicles" and insert "**a vehicle being**".
- 8 Page 36, line 8, delete "to or from an address" and insert "**for**
- 9 **purposes of sale by a licensed Indiana dealer.**".
- 10 Page 36, delete line 9.
- 11 Page 46, line 34, delete "landline".

- 16 Page 78, line 13, after "compliance" insert "**or noncompliance**".
- 17 Page 80, between lines 18 and 19, begin a new paragraph and insert:
- 18 "SECTION 77. IC 23-17-23-1 IS AMENDED TO READ AS
- 19 FOLLOWS [EFFECTIVE UPON PASSAGE]: Sec. 1. The secretary of
- 20 state may commence a proceeding under section 2 of this chapter to

- 1 administratively dissolve a corporation if the following occur:
- 2 (1) The corporation does not pay within sixty (60) days after they
- 3 are due any taxes or penalties imposed by this article or other law.
- 4 (2) The corporation does not deliver the corporation's annual
- 5 report to the secretary of state within sixty (60) days after the
- 6 report is due.
- 7 (3) The corporation is without a registered agent or registered
- 8 office in Indiana for at least sixty (60) days.
- 9 (4) The corporation does not notify the secretary of state within
- 10 sixty (60) days that the corporation's:
- 11 (A) registered agent or registered office has been changed;
- 12 (B) registered agent has resigned; or
- 13 (C) registered office has been discontinued.
- 14 (5) The corporation's period of duration, if any, stated in the
- 15 corporation's articles of incorporation expires.
- 16 **(6) The secretary receives credible evidence that the**
- 17 **corporation is engaged in:**
- 18 **(A) illegal activity; or**
- 19 **(B) activity not authorized by the corporation's articles of**
- 20 **incorporation."**
- 21 Page 86, line 28, delete "[EFFECTIVE JULY 1, 2012] (a) As used
- 22 in this" and insert "**An emergency is declared for this act.**".
- 23 Page 86, delete lines 29 through 42.
- 24 Delete page 87.
- 25 Renumber all SECTIONS consecutively.
