A CONCURRENT RESOLUTION congratulating Jerry Thacker,
2012 Indiana Superintendent of the Year.

Whereas, Penn-Harris-Madison School Corporation superintendent Dr. Jerry Thacker has been named Indiana's 2012 Superintendent of the Year by the Indiana Association of Public School Superintendents;

Whereas, Dr. Jerry Thacker was selected from seven District Superintendents of the Year in recognition of Penn-Harris-Madison School Corporation's many accomplishments under his exemplary leadership;

Whereas, During the 2009-2010 school year, every elementary and middle school in Dr. Thacker's district achieved Adequate Yearly Progress, five of the schools were 4-Star schools, and Penn High School was named one of 25 exemplary AP schools in Indiana. The district is among the top 5 percent in the state for SAT and AP scores;

Whereas, Dr. Thacker's innovative direction led to his district's creative use of available resources to boost instructional programs, and to save millions of dollars on energy costs, property, casualty, and health insurance;

Whereas, Dr. Thacker has worked in Educational Administration for twenty-one years, in positions ranging from administrator in the Metropolitan School Corporation of Lawrence Township, superintendent of Logansport Community School Corporation, to his current position of superintendent of Penn-Harris-Madison School Corporation, one of the best high schools in the nation according to U.S. News and World Report; and
