DIGEST OF SB 117 (Updated March 25, 2013 12:00 pm - DI 69)

**Citations Affected:** IC 34-6; IC 34-31.

**Synopsis:** Ice skating rink liability. Specifies the duties and responsibilities of ice skaters and a postsecondary educational institution that operates an ice skating rink. Specifies that the operator of an ice skating rink who fulfills the operator's duties and responsibilities has a complete defense to a civil action. Makes conforming amendments.

**Effective:** July 1, 2013.

## ENGROSSED SENATE BILL No. 117

A BILL FOR AN ACT to amend the Indiana Code concerning civil procedure.

*Be it enacted by the General Assembly of the State of Indiana:*

1 SECTION 1. IC 34-6-2-60.4 IS ADDED TO THE INDIANA CODE  
2 AS A NEW SECTION TO READ AS FOLLOWS [EFFECTIVE JULY  
3 1, 2013]: **Sec. 60.4. "Ice skater", for purposes of IC 34-31-6.5,**  
4 **means a person, including an invitee, who wears ice skates while in**  
5 **an ice skating rink for the purpose of recreational or competitive**  
6 **ice skating, whether or not the person pays consideration for**  
7 **entrance to the skating rink.**

8 SECTION 2. IC 34-6-2-60.6 IS ADDED TO THE INDIANA CODE  
9 AS A NEW SECTION TO READ AS FOLLOWS [EFFECTIVE JULY  
10 1, 2013]: **Sec. 60.6. "Ice skating rink", for purposes of IC 34-31-6.5,**  
11 **means a building, facility, or other property where an area**  
12 **specifically designed for use for recreational or competitive ice**  
13 **skating is present.**

14 SECTION 3. IC 34-6-2-91 IS AMENDED TO READ AS  
15 FOLLOWS [EFFECTIVE JULY 1, 2013]: Sec. 91. (a) "Operator", for  
16 purposes of IC 34-30-3, means a person who is an owner, a lessee, a  
17 tenant, or an occupant of land or premises that are used in the

1 production of agricultural products.

2 (b) "Operator", for purposes of IC 34-31-6, means a person or an  
3 entity, other than a governmental entity or an employee of a  
4 governmental entity, that owns, manages, controls, directs, or has  
5 operational responsibility for a roller skating rink.

6 (c) "Operator", for purposes of IC 34-31-6.5, means an  
7 approved postsecondary educational institution (as defined in  
8 IC 21-7-13-6) that owns, manages, controls, directs, or has  
9 operational responsibility for an ice skating rink.

10 SECTION 4. IC 34-31-6.5 IS ADDED TO THE INDIANA CODE  
11 AS A NEW CHAPTER TO READ AS FOLLOWS [EFFECTIVE  
12 JULY 1, 2013]:

13 **Chapter 6.5. Limited Liability for Ice Skating Rinks**

14 **Sec. 1. This chapter applies only to an ice skating rink that is  
15 operated by a postsecondary educational institution.**

16 **Sec. 2. An operator shall do all of the following with respect to  
17 an ice skating rink:**

18 (1) Post the:

19 (A) duties of ice skaters; and

20 (B) duties, obligations, and liabilities of the operator;

21 as prescribed in this chapter in at least three (3) conspicuous  
22 locations in the ice skating rink.

23 (2) Maintain the stability and legibility of all signs, symbols,  
24 and posted notices required by this chapter.

25 (3) When the ice skating rink is open for a session, have at  
26 least one (1) floor supervisor on duty for every one hundred  
27 seventy-five (175) ice skaters. A floor supervisor:

28 (A) must have received appropriate training to carry out  
29 the floor supervisor's duties; and

30 (B) must use reasonable care in carrying out the floor  
31 supervisor's duties.

32 (4) Maintain the ice skating surface in proper and reasonably  
33 safe condition.

34 (5) Clean and inspect the ice skating surface before each  
35 skating session.

36 (6) Resurface the ice at appropriate intervals.

37 (7) Maintain in good and safe condition the railings,  
38 kickboards, risers, floors, areas open to ice skaters, and walls  
39 surrounding the ice skating surface.

40 (8) Maintain rental skates in good mechanical condition.

41 (9) Comply with all applicable state and local fire safety  
42 codes, building codes, and other safety codes applicable to an

2 (10) Use reasonable care in supervising ice skaters to comply  
3 with the requirements of section 3 of this chapter.

4 **Sec. 3. An ice skater must do all of the following:**

5 (1) Maintain reasonable control of the ice skater's speed and  
6 course at all times.

7 (2) Heed all posted signs and warnings.

8 (3) Maintain a proper view to avoid other ice skaters and  
9 objects.

10 (4) Accept the responsibility for the following:

11 (A) Knowing the range of the ice skater's ability to  
12 negotiate the intended direction of travel while on ice  
13 skates.

14 (B) Skating within the limits of the ice skater's ability.

15 (5) Refrain from acting in a manner that may cause or  
16 contribute to the injury of the ice skater or any other person.

17 **Sec. 4. (a) Ice skaters are considered to:**

18 (1) have knowledge of; and

19 (2) assume;

20 the risks of ice skating.

21 (b) For purposes of this chapter, risks of ice skating include the  
22 following:

23 (1) Injuries that result from collisions or incidental contact  
24 with other ice skaters or other individuals who are properly  
25 on the skating surface.

26 (2) Injuries that result from falls caused by loss of balance.

27 (3) Injuries that involve objects or artificial structures that:  
28 (A) are properly within the intended path of travel of the  
29 ice skater; and

30 (B) are not otherwise attributable to an operator's breach  
31 of the operator's duties or responsibilities under section 2  
32 of this chapter.

33 **Sec. 5. (a) Except as provided in subsection (b) and**  
34 **notwithstanding IC 34-51-2-6 concerning comparative fault, the**  
35 **assumption of risk under section 4 of this chapter is a complete**  
36 **defense to an action against an operator by an ice skater for**  
37 **injuries and property damage resulting from the assumed risks.**

38 (b) The following applies if an operator has violated any one (1)  
39 of the operator's duties or responsibilities under section 2 of this  
40 chapter:

41 (1) The complete defense against an action against an  
42 operator under subsection (a) does not apply.
