MR. SPEAKER:

I move that Engrossed Senate Bill 538 be amended to read as follows:

- 1 Delete the title and insert the following:
- 2 A BILL FOR AN ACT to amend the Indiana Code concerning
- 3 motor vehicles and to make an appropriation.
- 4 Page 4, between lines 31 and 32, begin a new paragraph and insert:
- 5 "SECTION 3. IC 8-2.1-23-1 IS AMENDED TO READ AS
- 6 FOLLOWS [EFFECTIVE JULY 1, 2013]: Sec. 1. The motor carrier
- 7 regulation fund is established for the ~~purpose~~ **purposes** of:
- 8 (1) funding:
- 9 (1) ~~(A)~~ **(A)** the administration and enforcement of this article; and
- 10 (2) ~~(B)~~ **(B)** the administration and enforcement of IC 6-6-4.1 and
- 11 IC 6-8.1-4-4; **and**
- 12 (2) **supplementing the funding of the department of state**
- 13 **revenue in carrying out its powers and duties under IC 9-20.**
- 14 SECTION 4. IC 8-2.1-23-2 IS AMENDED TO READ AS
- 15 FOLLOWS [EFFECTIVE JULY 1, 2013]: Sec. 2. (a) The treasurer of
- 16 state shall deposit:
- 17 (1) fees collected under this article, IC 9-20-18-14.5, and
- 18 IC 9-29-6-1.5; **and**
- 19 (2) **amounts appropriated under section 5 of this chapter;**
- 20 in the motor carrier regulation fund.
- 21 (b) **Money in the fund is annually appropriated to the**
- 22 **department of state revenue for its use in carrying out the purposes**
- 23 **of this chapter.**
- 24 SECTION 5. IC 8-2.1-23-5 IS ADDED TO THE INDIANA CODE

1 AS A NEW SECTION TO READ AS FOLLOWS [EFFECTIVE JULY  
2 1, 2013]: **Sec. 5. (a) Before July 1, 2014, the department of state  
3 revenue shall hire additional inspectors to enforce this article and  
4 IC 9-20. Subject to subsection (b), the number of additional  
5 inspectors hired under this section is left to the discretion of the  
6 department of state revenue.**

7 **(b) At least fourteen (14) additional inspectors must be hired  
8 under this section. The number of inspectors hired under this  
9 section must enable the department of state revenue to adequately  
10 staff the permanent weigh stations operated under IC 9-20-17  
11 without reducing the number of roadside inspections conducted  
12 under IC 9-20-17.**

13 **(c) There is annually appropriated to the department of state  
14 revenue from the state general fund an amount sufficient to employ  
15 the inspectors hired under this section."**
