MR. SPEAKER:

I move that Engrossed Senate Bill 567 be amended to read as follows:

- 1 Page 2, after line 36, begin a new paragraph and insert:
- 2 "SECTION 3. IC 10-13-2-6.5 IS ADDED TO THE INDIANA
- 3 CODE AS A NEW SECTION TO READ AS FOLLOWS
- 4 [EFFECTIVE JULY 1, 2013]: **Sec. 6.5. (a) Before July 1, 2014, the**
- 5 **division, under the direction and supervision of the superintendent,**
- 6 **shall institute a centralized crime and delinquency data collection**
- 7 **program that is certified by the Federal Bureau of Investigation.**
- 8 **(b) A data collection program complies with this section if an**
- 9 **application for certification has been submitted to the Federal**
- 10 **Bureau of Investigation before July 1, 2014.**
- 11 **(c) The superintendent shall adopt rules to implement this**
- 12 **section.**
- 13 SECTION 4. IC 16-19-13-7 IS ADDED TO THE INDIANA CODE
- 14 AS A NEW SECTION TO READ AS FOLLOWS [EFFECTIVE JULY
- 15 1, 2013]: **Sec. 7. (a) Before July 1, 2014, and at least one (1) time**
- 16 **every two (2) years thereafter, the office or the state department**
- 17 **shall conduct a survey to determine the number of Indiana**
- 18 **residents who have been the victim of a crime of domestic violence**
- 19 **(as defined by IC 35-31.5-2-78) or a sex offense (as defined by**
- 20 **IC 11-8-8-5.2). The survey shall include persons who have been the**
- 21 **victim of a delinquent act that would be a crime of domestic**
- 22 **violence or a sex offense if committed by an adult.**
- 23 **(b) The office or state department may contract with a third**
- 24 **party to conduct the survey described in subsection (a).**

1 **(c) Information contained in a survey described in subsection (a)**
2 **that identifies or could be used to determine the identity of a**
3 **person responding to the survey is confidential. All other**
4 **information contained in the survey is not confidential and is**
5 **available for inspection and copying under IC 5-14-3.**

6 **(d) The state department shall adopt rules under IC 4-22-2 to**
7 **implement this section.**

8 SECTION 5. [EFFECTIVE JULY 1, 2013] **(a) The general**
9 **assembly urges the legislative council to assign to the criminal law**
10 **and sentencing policy study committee or another existing study**
11 **committee, for study during the 2013 legislative interim, the topic**
12 **of the collection of crime and delinquency data. If assigned this**
13 **topic, the committee shall consider the extent to which certain**
14 **crimes, including crimes of domestic violence and sex crimes, are**
15 **underreported to law enforcement.**

16 **(b) This SECTION expires November 1, 2013."**
