MR. SPEAKER:

I move that Engrossed Senate Bill 621 be amended to read as follows:

- 1 Page 3, line 14, delete "a division of the department of".
- 2 Page 3, line 15, delete "public safety".
- 3 Page 3, line 15, delete "a director of public" and insert "**the county**
- 4 **sheriff and includes all dissolved law enforcement departments as**
- 5 **provided in section 5.2 of this chapter.**".
- 6 Page 3, delete line 16.
- 7 Page 5, between lines 40 and 41, begin a new paragraph and insert:
- 8 "SECTION 8. IC 36-3-1-5.2 IS ADDED TO THE INDIANA CODE
- 9 AS A NEW SECTION TO READ AS FOLLOWS [EFFECTIVE JULY
- 10 1, 2013]: **Sec. 5.2. (a) As used in this section, "consolidated law**
- 11 **enforcement department" refers to the law enforcement**
- 12 **department established under section 5.1 of this chapter.**
- 13 **(b) As used in this section, "dissolved law enforcement**
- 14 **department" refers to a law enforcement department of:**
- 15 **(1) an excluded city; or**
- 16 **(2) any other political subdivision in the county.**
- 17 **The term does not include the consolidated law enforcement**
- 18 **department or the county sheriff's department.**
- 19 **(c) On January 1, 2015, the following apply:**
- 20 **(1) Each dissolved law enforcement department is abolished.**
- 21 **(2) All the personal property under the control of a dissolved**
- 22 **law enforcement department is transferred to the**
- 23 **consolidated law enforcement department.**
- 24 **(3) All the records of a dissolved law enforcement department**

- 1 are transferred to the consolidated law enforcement
- 2 department.
- 3 **(4) The employees of each dissolved law enforcement**
- 4 **department become employees of the consolidated law**
- 5 **enforcement department.**
- 6 **(5) An employee of a dissolved law enforcement department**
- 7 **remains a member of the pension fund that the employee was**
- 8 **a member of on December 31, 2014. The employee retains,**
- 9 **after the consolidation, credit in the fund for service earned**
- 10 **while an employee of the dissolved law enforcement**
- 11 **department and continues to earn service credit in that fund**
- 12 **as a member of the consolidated law enforcement department**
- 13 **for purposes of determining the member's benefits from the**
- 14 **fund.**
- 15 **(6) The merit board and the merit system of each dissolved**
- 16 **law enforcement department are dissolved, and the duties of**
- 17 **the merit board are transferred to and assumed by the merit**
- 18 **board for the consolidated law enforcement department.**
- 19 **(d) A reference to a dissolved law enforcement department in a**
- 20 **statute, rule, or legal document is, after June 30, 2015, considered**
- 21 **a reference to the consolidated law enforcement department."**
- 22 Renumber all SECTIONS consecutively.
