# HOUSE MOTION \_\_\_\_\_

MR. SPEAKER:

I move that House Bill 1357 be amended to read as follows:

- 1 Delete the title and insert the following:
- 2 A BILL FOR AN ACT to amend the Indiana Code concerning
- 3 education and insurance.
- 4 Page 9, between lines 15 and 16, begin a new paragraph and insert:
- 5 "SECTION 6. IC 20-26-5-4.1 IS ADDED TO THE INDIANA
- 6 CODE AS A NEW SECTION TO READ AS FOLLOWS
- 7 [EFFECTIVE JULY 1, 2013]: **Sec. 4.1. A superintendent hired under**
- 8 **section 4 of this chapter must demonstrate that the superintendent**
- 9 **fulfills the following requirements:**
- 10 (1) **Has sworn or affirmed the oath required under**
- 11 **IC 20-28-5-4.**
- 12 (2) **Has not been convicted of a felony set forth in**
- 13 **IC 20-28-5-8(c).**
- 14 (3) **Does not have a delinquent tax liability with the**
- 15 **department of state revenue.**
- 16 (4) **Has successfully completed training in:**
- 17 (A) **cardiopulmonary resuscitation that includes a test**
- 18 **demonstration on a mannequin;**
- 19 (B) **removing a foreign body causing an obstruction in an**
- 20 **airway;**
- 21 (C) **the Heimlich maneuver; and**
- 22 (D) **the use of an automated external defibrillator.**
- 23 (5) **Either:**
- 24 (A) **holds a valid certification in each of the procedures**

- 1 described in subdivision (4) issued by:
- 2 (i) the American Red Cross;
- 3 (ii) the American Heart Association; or
- 4 (iii) a comparable organization or institution approved
- 5 by the department; or
- 6 (B) has physical limitations that make it impracticable for
- 7 the applicant to complete a course or certification
- 8 described in subdivision (4) or clause (A).
- 9 (6) Has successfully completed education and training in the
- 10 following areas:
- 11 (A) The prevention of child suicide and the recognition of
- 12 signs that a student may be considering suicide.
- 13 (B) Warning signs of child abuse or child sexual abuse.
- 14 (C) Legal reporting requirements for suspected child abuse
- 15 or child sexual abuse.
- 16 (7) Has at least seven (7) years experience in education
- 17 administration."
- 18 Page 11, after line 2, begin a new paragraph and insert:
- 19 "SECTION 11. IC 27-1-15.6 IS REPEALED [EFFECTIVE JULY
- 20 1, 2013]. (Insurance Producers).
- 21 SECTION 12. IC 27-1-15.7 IS REPEALED [EFFECTIVE JULY 1,
- 22 2013]. (Insurance Producer License Renewal).
- 23 SECTION 13. IC 27-1-15.8 IS REPEALED [EFFECTIVE JULY 1,
- 24 2013]. (Surplus Lines Producers).
- 25 SECTION 14. [EFFECTIVE JULY 1, 2013] (a) **The legislative**
- 26 **services agency shall prepare legislation for introduction in the**
- 27 **2014 regular session of the general assembly to organize and**
- 28 **correct statutes affected by this act, if necessary.**
- 29 **(b) This SECTION expires December 31, 2014."**
- 30 Renumber all SECTIONS consecutively.
