

**CONFERENCE COMMITTEE REPORT
DIGEST FOR ESB 338**

Citations Affected: IC 2-5-38.1-2.2; IC 20-18-2; IC 20-19-3-12.2; IC 20-20-8; IC 20-30-2-2.2; IC 20-31-5.

Synopsis: Absenteeism; school improvement plans. Conference committee report for ESB 338. Refers issues related to absenteeism to the commission on education study committee. Requires the department of education to provide resources and guidance to school corporations concerning evidence-based practices and effective strategies to reduce absenteeism. Makes changes to the definition of: (1) chronic absenteeism; and (2) habitual truant. Requires school corporations and schools to identify contributing factors to absenteeism and to develop chronic absence reduction plans. Provides that a school corporation must include the number of students who are habitually truant in the school corporation's annual performance report. Provides that a school that is designated in the top category or designation of school improvement in the year immediately preceding a year in which the school's strategic and continuous school improvement plan (plan) initially goes into effect is not required to include certain achievement objectives or components in the school's plan. Makes conforming amendments. **(This conference committee report: (1) removes language added in the house concerning a charter school organizer that has had the organizer's charter revoked or not renewed, and concerning the Paths to QUALITY program and a matching grant program for early education providers; (2) changes the schools that are not required to include certain components in the schools' plans from those in the top two categories of school improvement to those in the top category of school improvement; and (3) reconciles conflicts with other bills.)**

2 JULY 1, 2013]: Sec. 2.2. (a) As used in this section, "eligible student"
3 means a student in grade 11 or 12 who has:

- 4 (1) failed the ISTEP+ graduation exam at least twice;
- 5 (2) been determined to be chronically absent, by missing ~~more~~
6 ~~than ten (10) unexcused days of school in one (1) ten percent~~
7 **(10%) or more of a school year for any reason;**
- 8 (3) been determined to be a habitual truant, as identified under
9 IC 20-33-2-11;
- 10 (4) been significantly behind in credits for graduation, as
11 identified by an individual's school principal;
- 12 (5) previously undergone at least a second suspension from school
13 for the school year under IC 20-33-8-14 or IC 20-33-8-15;
- 14 (6) previously undergone an expulsion from school under
15 IC 20-33-8-14, IC 20-33-8-15, or IC 20-33-8-16; or
- 16 (7) been determined by the individual's principal and the
17 individual's parent or guardian to benefit by participating in the
18 school flex program.

19 (b) An eligible student who participates in a school flex program
20 must:

- 21 (1) attend school for at least three (3) hours of instructional time
22 per school day;
- 23 (2) pursue a timely graduation;
- 24 (3) provide evidence of college or technical career education
25 enrollment and attendance or proof of employment and labor that
26 is aligned with the student's career academic sequence under rules
27 established by the Indiana bureau of child labor;
- 28 (4) not be suspended or expelled while participating in a school
29 flex program;
- 30 (5) pursue course and credit requirements for a general diploma;
31 and
- 32 (6) maintain a ninety-five percent (95%) attendance rate.

33 (c) A school may allow an eligible student in grade 11 or 12 to
34 complete an instructional day that consists of three (3) hours of
35 instructional time if the student participates in the school flex program.

36 (d) If one (1) or more students participate in a school flex program,
37 the principal shall, on forms provided by the department, submit a
38 yearly report to the department of student participation and graduation

15 system where results are measured by setting benchmarks for progress
16 on an individual school basis.

19 SECTION 9. IC 20-31-5-6, AS AMENDED BY P.L.66-2009,
20 SECTION 2, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
21 JULY 1, 2013]: Sec. 6. (a) **This section does not apply to a school**
22 **that is designated in the top category or designation of school**
23 **improvement under IC 20-31-8-4 in the year immediately**
24 **preceding the year in which the school's initial plan is**
25 **implemented.** A plan must contain the following components for the
26 school:

27 (1) A list of the statutes and rules that the school wishes to have
28 suspended from operation for the school.

29 (2) A description of the curriculum and information concerning
30 the location of a copy of the curriculum that is available for
31 inspection by members of the public.

32 (3) A description and name of the assessments that will be used
33 in the school in addition to ISTEP program assessments.

34 (4) A plan to be submitted to the governing body and made
35 available to all interested members of the public in an easily
36 understood format.

37 (5) A provision to maximize parental participation in the school,
38 which may include providing parents with:

39 (A) access to learning aids to assist students with school work
40 at home;

41 (B) information on home study techniques; and

42 (C) access to school resources.

43 (6) For a secondary school, a provision to do the following:

44 (A) Offer courses that allow all students to become eligible to
45 receive an academic honors diploma.

46 (B) Encourage all students to earn an academic honors
47 diploma or complete the Core 40 curriculum.

48 (7) A provision to maintain a safe and disciplined learning
49 environment for students and teachers that complies with the
50 governing body's plan for improving student behavior and

- 1 discipline developed under IC 20-26-5-32.
2 (8) A provision for the coordination of technology initiatives and
3 ongoing professional development activities.
4 (b) If, for a purpose other than a plan under this chapter, a school
5 has developed materials that are substantially similar to a component
6 listed in subsection (a), the school may substitute those materials for
7 the component listed in subsection (a).
8 **SECTION 10. An emergency is declared for this act.**
