

**CONFERENCE COMMITTEE REPORT
DIGEST FOR EHB 1333**

Citations Affected: IC 33-32-2-9; IC 36-2.

Synopsis: Public offices. CONFERENCE COMMITTEE REPORT FOR EHB 1333. Provides that county treasurers, county auditors, county recorders, circuit court clerks, and county surveyors (county offices) may attend the required county officer training courses after being elected to office (currently they are required to take the training after taking office). Provides that the county elected officials training fund (fund) supplements appropriations from the county general fund for payment of the training courses. Adds circuit court clerks to the county officials whose training may be paid for by money in the fund. Provides that a training course that an individual completes after being elected to a county office and before the individual begins serving in office applies toward the training requirements. Requires all county offices to fulfill the training requirements for each elected term. Requires an individual elected to the office of county surveyor on or after June 30, 2013, to complete at least: (1) 15 hours of training courses within one year; and (2) 40 hours of training courses within three years; after the individual is elected to that office. (Current law: (1) exempts from the training requirements an actively registered professional surveyor, a graduate of an accredited surveying curriculum, or a surveyor intern who is elected to the office of county surveyor; and (2) requires an individual elected to the office of county surveyor who is not exempted to complete 24 hours of training within two years after beginning the surveyor's term). Provides that educational courses regarding land surveying that are taken by a county surveyor who is an actively registered professional surveyor count toward the training requirement. Provides that if an individual is appointed to fill a vacancy in a county office: (1) the individual may (but is not required to) take the training courses; and (2) the county is required to pay for the training courses. Urges the legislative council to assign to a study committee during the 2013 legislative interim the topic of having the state board of accounts (board) set control standards and control procedures for internal control systems for any local government entity: (A) that is required to submit financial reports to the board; and (B) for which the board is not currently required to set control standards and control procedures. **(This conference committee report does the following: (1) Removes a provision specifying that the state board of accounts sets internal standards and internal procedures for internal control systems for local government entities that submit financial reports to the board. (2) Adds a provision urging the assignment to an interim study committee, of the topic of the board setting control standards and control procedures for internal control systems for local government entities: (A) that are required to submit financial reports to the board;**

and (B) for which the board is not currently required to set control standards and control procedures.)

Effective: July 1, 2013.

Your Conference Committee appointed to confer with a like committee from the Senate upon Engrossed Senate Amendments to Engrossed House Bill No. 1333 respectfully reports that said two committees have conferred and agreed as follows to wit:

that the House recede from its dissent from all Senate amendments and that the House now concur in all Senate amendments to the bill and that the bill be further amended as follows:

9 November 2, 2010, shall complete at least:
10 (1) fifteen (15) hours of training courses within one (1) year; and
11 (2) forty (40) hours of training courses within three (3) years;
12 after ~~beginning the individual's term as circuit court clerk:~~ **the**
13 **individual is elected to the office of circuit court clerk.**
14 (c) **A training course that an individual completes:**
15 (1) **after being elected to the office of circuit court clerk; and**
16 (2) **before the individual begins serving in the office of circuit**
17 **court clerk;**
18 **shall be counted toward the requirements under subsection (b).**
19 (d) **An individual shall fulfill the training requirements**
20 **established by subsection (b) for each term to which the individual**
21 **is elected as circuit court clerk.**
22 (e) **This subsection applies only to an individual appointed to fill**

1 a vacancy in the office of circuit court clerk. An individual
 2 described in this subsection may, but is not required to, take
 3 training courses required by subsection (b). If an individual
 4 described in this subsection takes a training course required by
 5 subsection (b) for an elected circuit court clerk, the county shall
 6 pay for the training course as if the individual had been an elected
 7 circuit court clerk.

8 SECTION 2. IC 36-2-7-19, AS AMENDED BY SEA 85-2013,
 9 SECTION 152, IS AMENDED TO READ AS FOLLOWS
 10 [EFFECTIVE JULY 1, 2013]: Sec. 19. (a) As used in this section,
 11 "fund" refers to a county elected officials training fund established
 12 under subsection (b).

13 (b) Each county legislative body shall before July 1, 2011, establish
 14 a county elected officials training fund **to supplement appropriations**
 15 **that may come from the county general fund to provide training of**
 16 **elected officials.** The county fiscal body shall appropriate money from
 17 the fund.

18 (c) The fund consists of money deposited under IC 36-2-7.5-6(b)(3)
 19 and any other sources required or permitted by law. Money in the fund
 20 does not revert to the county general fund.

21 (d) Money in the fund shall be used solely to provide training of
 22 county elected officials required by **IC 33-32-2-9**, IC 36-2-9-2.5,
 23 IC 36-2-9.5-2.5, IC 36-2-10-2.5, IC 36-2-11-2.5, **and IC 36-2-12-2.5.**
 24 **and other similar laws.**

25 SECTION 3. IC 36-2-9-2.5, AS ADDED BY P.L.120-2012,
 26 SECTION 7, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
 27 JULY 1, 2013]: Sec. 2.5. (a) As used in this section, "training courses"
 28 refers to training courses related to the office of county auditor that are
 29 **compiled or** developed by the Association of Indiana Counties and
 30 approved by the state board of accounts.

31 (b) An individual elected to the office of county auditor **on or** after
 32 November 6, 2012, shall complete at least:

- 33 (1) fifteen (15) hours of training courses within one (1) year; and
- 34 (2) forty (40) hours of training courses within three (3) years;

35 after ~~beginning the county auditor's term.~~ **the individual is elected to**
 36 **the office of county auditor.**

37 (c) **A training course that an individual completes:**

- 38 (1) **after being elected to the office of county auditor; and**

 3 JULY 1, 2013]: Sec. 2.5. (a) As used in this section, "training courses"
 4 refers to training courses related to the office of county auditor that are
 5 **compiled or** developed by the Association of Indiana Counties and
 6 approved by the state board of accounts.

7 (b) An individual elected to the office of county auditor **on or** after
 8 November 6, 2012, shall complete at least:

9 (1) fifteen (15) hours of training courses within one (1) year; and

10 (2) forty (40) hours of training courses within three (3) years;

11 after ~~beginning the county auditor's term.~~ **the individual is elected to**
 12 **the office of county auditor.**

13 (c) **A training course that an individual completes:**

14 (1) **after being elected to the office of county auditor; and**

15 (2) **before the individual begins serving in the office of county**

34 (b) An individual elected to the office of county treasurer **on or** after
 35 November 6, 2012, shall complete at least:

36 (1) fifteen (15) hours of training courses within one (1) year; and

37 (2) forty (40) hours of training courses within three (3) years;

38 after ~~beginning the county treasurer's term.~~ **the individual is elected to**
 39 **the office of county treasurer.**

40 (c) **A training course that the individual completes:**

41 (1) **after being elected to the office of county treasurer; and**

42 (2) **before the individual begins serving in the office of county**
 43 **treasurer;**

44 **shall be counted toward the requirements under subsection (b).**

45 (d) **An individual shall fulfill the training requirements**
 46 **established by subsection (b) for each term to which the individual**

 7 JULY 1, 2013]: Sec. 2.5. (a) As used in this section, "training courses"
 8 refers to training courses related to the office of county recorder that
 9 are **compiled or** developed by the Association of Indiana Counties and
 10 approved by the state board of accounts.

11 (b) An individual elected to the office of county recorder after
 12 November 4, 2008, shall complete at least:

13 (1) fifteen (15) hours of training courses within one (1) year; and
 14 (2) forty (40) hours of training courses within three (3) years;
 15 after ~~beginning the county recorder's term.~~ **the individual is elected to**
 16 **the office of county recorder.**

17 (c) A training course that the individual completes:

18 (1) after being elected to the office of county recorder; and
 19 (2) before the individual begins serving in the office of county
 20 recorder;

21 shall be counted toward the requirements under subsection (b).

22 (d) An individual shall fulfill the training requirements
 23 established by subsection (b) for each term to which the individual
 24 is elected as county recorder.

25 (e) This subsection applies only to an individual appointed to fill
 26 a vacancy in the office of county recorder. An individual described
 27 in this subsection may, but is not required to, take any training
 28 courses required by subsection (b). If an individual described in
 29 this subsection takes a training course required by subsection (b)
 30 for an elected county recorder, the county shall pay for the training
 31 course as if the individual had been an elected county recorder.

32 SECTION 7. IC 36-2-12-2.5, AS AMENDED BY P.L.57-2013,
 33 SECTION 90, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
 34 JULY 1, 2013]: Sec. 2.5. (a) This section does not apply to an
 35 individual who is:

36 (1) an actively registered professional surveyor;
 37 (2) a graduate of an accredited surveying curriculum; or
 38 (3) a surveyor intern (as defined in IC 25-21.5-1-9.7).

39 (a) As used in this section, "training course" refers to:

40 (1) a training course related to the office of county surveyor
 41 that is compiled or developed by the Association of Indiana
 42 Counties and approved by the state board of accounts; or
 43 (2) an educational course regarding land surveying that is
 44 taken by an individual who is:

45 (A) serving in the office of county surveyor; and
 46 (B) an actively registered professional surveyor.

47 (b) An individual elected to the office of county surveyor after June
 48 30, 2009, **but before July 1, 2013**, shall, within two (2) years after
 49 beginning the county surveyor's term, complete at least twenty-four
 50 (24) hours of training courses. ~~related to land surveying that are~~
 51 ~~developed by the Association of Indiana Counties and approved by the~~

1 state board of accounts.

2 (c) An individual elected to the office of county surveyor after
3 June 30, 2013, shall complete at least:

4 (1) fifteen (15) hours of training courses within one (1) year;
5 and

6 (2) forty (40) hours of training courses within three (3) years;
7 after the individual is elected to the office of county surveyor.

8 (d) A training course that an individual completes:

9 (1) after being elected to the office of county surveyor; and

10 (2) before that individual begins serving in the office of county
11 surveyor;

12 shall be counted toward the requirements under subsection (c).

13 (e) (e) An individual shall fulfill the training requirement
14 established by subsection (b) (c) for each term the individual serves.

15 (f) This subsection applies only to an individual appointed to fill
16 a vacancy in the office of county surveyor. An individual described
17 in this subsection may, but is not required to, take any training
18 courses required by subsection (c). If an individual described in
19 this subsection takes a training course required by subsection (c)
20 for an elected county surveyor, the county shall pay for the
21 training course as if the individual had been an elected county
22 surveyor.

23 SECTION 8. [EFFECTIVE JULY 1, 2013] (a) As used in this
24 SECTION, "board" refers to the state board of accounts.

25 (b) The definitions in IC 5-11-1-16 apply to this SECTION.

26 (c) As used in this SECTION, "legislative council" refers to the
27 legislative council established by IC 2-5-1.1-1.

28 (d) As used in this SECTION, "study committee" means either
29 of the following:

30 (1) A statutory committee established under IC 2-5.

31 (2) An interim study committee.

32 (e) The legislative council is urged to assign to a study
33 committee during the 2013 legislative interim the topic of having
34 the board set internal control standards and internal control
35 procedures for the internal control systems of any municipality or
36 other local government unit, entity, or instrumentality:

37 (1) that is required to submit financial reports to the board;
38 and

39 (2) for which the board is not currently required under
40 IC 5-11-1-27 to set internal control standards and internal
41 control procedures.

42 (f) If the topic described in subsection (e) is assigned to a study
43 committee, the study committee shall issue a final report to the
44 legislative council containing the study committee's findings and
45 recommendations, including any recommended legislation
46 concerning the topic, in an electronic format under IC 5-14-6 not
47 later than November 1, 2013.

48 (g) This SECTION expires December 31, 2013.
