DIGEST OF INTRODUCED BILL

Citations Affected: IC 9-13-2-27.7; IC 9-18; IC 9-29-5-38.7.

Synopsis: Commendation for valor license plates. Establishes the commendation for valor license plate (plate). Specifies that an individual is eligible to receive a plate by: (1) presenting a certification to the bureau of motor vehicles from the United States Department of Defense that the individual is the recipient of a medal or commendation for valor while serving in the United States Armed Forces; and (2) paying a certain fee for the plate.

Effective: July 1, 2013.

A BILL FOR AN ACT to amend the Indiana Code concerning motor vehicles.

Be it enacted by the General Assembly of the State of Indiana:

1 SECTION 1. IC 9-13-2-27.7 IS ADDED TO THE INDIANA CODE
2 AS A **NEW** SECTION TO READ AS FOLLOWS [EFFECTIVE JULY
3 1, 2013]: **Sec. 27.7. "Commendation for valor", for purposes of**
4 **IC 9-18-55, has the meaning set forth in IC 9-18-55-2.**
5 SECTION 2. IC 9-18-15-1, AS AMENDED BY P.L.87-2010,
6 SECTION 10, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
7 JULY 1, 2013]: Sec. 1. (a) A person who is the registered owner or
8 lessee of a:
9 (1) passenger motor vehicle;
10 (2) motorcycle;
11 (3) recreational vehicle; or
12 (4) vehicle registered as a truck with a declared gross weight of
13 not more than eleven thousand (11,000) pounds;
14 registered with the bureau or who makes an application for an original
15 registration or renewal registration of a vehicle may apply to the bureau
16 for a personalized license plate to be affixed to the vehicle for which
17 registration is sought instead of the regular license plate.

 6 may apply to the bureau for a personalized license plate to be affixed
 7 to the vehicle for which registration is sought instead of the regular
 8 special recognition license plate.

9 SECTION 3. IC 9-18-25-1, AS AMENDED BY P.L.87-2010,
 10 SECTION 18, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
 11 JULY 1, 2013]: Sec. 1. This chapter does not apply to the following:

28 SECTION 4. IC 9-18-55 IS ADDED TO THE INDIANA CODE AS
 29 A NEW CHAPTER TO READ AS FOLLOWS [EFFECTIVE JULY
 30 1, 2013]:

31 **Chapter 55. Commendation for Valor License Plates**

32 **Sec. 1. This chapter applies after December 31, 2013.**

33 **Sec. 2. As used in this chapter, "commendation for valor"**
 34 **means a medal or commendation for valor while serving in the**
 35 **United States Armed Forces, including but not limited to the**
 36 **Distinguished Flying Cross, the Silver Star, and the Bronze Star.**

37 **Sec. 3. (a) The bureau shall design and issue a commendation**
 38 **for valor license plate.**

39 **(b) A commendation for valor license plate must include the**
 40 **following:**

- 41 **(1) A basic design for the license plate, with consecutive**
 42 **numbers or letters, or both, to properly identify the vehicle.**

1 **(2) A background design, an emblem, or colors that designate**
2 **the license plate as a commendation for valor license plate.**
3 **(3) Any other information the bureau considers necessary.**
4 **Sec. 4. A commendation for valor license plate issued under this**
5 **chapter may be displayed on the following:**
6 **(1) A passenger motor vehicle.**
7 **(2) A truck registered as a truck with a declared gross weight**
8 **of not more than eleven thousand (11,000) pounds.**
9 **(3) A recreational vehicle.**
10 **(4) A motorcycle.**
11 **Sec. 5. After December 31, 2013, an individual who is a resident**
12 **of Indiana and is eligible to register a motor vehicle under this title**
13 **may apply for and receive a commendation for valor license plate**
14 **for one (1) or more motor vehicles upon doing the following:**
15 **(1) Completing an application for a commendation for valor**
16 **license plate.**
17 **(2) Presenting a certification to the bureau from the United**
18 **States Department of Defense that the individual is the**
19 **recipient of a medal or commendation for valor while serving**
20 **in the Unites States Armed Forces.**
21 **(3) Paying the fee under section 6 of this chapter.**
22 **Sec. 6. The fee for a commendation for valor license plate is the**
23 **fee set forth in IC 9-29-5-38.7.**
24 **SECTION 5. IC 9-29-5-38.7 IS ADDED TO THE INDIANA CODE**
25 **AS A NEW SECTION TO READ AS FOLLOWS [EFFECTIVE JULY**
26 **1, 2013]: Sec. 38.7. A vehicle registered under IC 9-18-55 is subject**
27 **to an annual registration fee for a vehicle of the same classification**
28 **under this chapter and any other fee or tax required of a person**
29 **registering a vehicle under this title.**
