

SENATE MOTION

MADAM PRESIDENT:

I move that Engrossed House Bill 1320 be amended to read as follows:

- 1 Page 30, line 39, delete "P.L.168-2011," and insert "HEA
2 1325-2013,".
3 Page 30, line 40, delete "11," and insert "10,".
4 Page 34, between lines 4 and 5, begin a new line block indented and
5 insert:
6 "(12) An individual who is not an employee of the state or a
7 political subdivision is considered to be a temporary employee of
8 the state for purposes of IC 22-3-2 through IC 22-3-6 while
9 serving as a member of a mobile support unit on duty for training,
10 an exercise, or a response, as set forth in
11 IC 10-14-3-19(c)(2)(B)."
12 Page 37, between lines 34 and 35, begin a new paragraph and insert:
13 "SECTION 14. IC 22-3-6-1.5 IS ADDED TO THE INDIANA
14 CODE AS A NEW SECTION TO READ AS FOLLOWS
15 [EFFECTIVE JULY 1, 2013]: **Sec. 1.5. (a) This section is effective**
16 **beginning July 1, 2014.**
17 **(b) For purposes of calculating the payment under section**
18 **1(k)(2) of this chapter to a hospital licensed under IC 16-21, the**
19 **payment owed for a claim submitted by the hospital for inpatient**
20 **or outpatient services or products must be the amount determined**
21 **under STEP TWO of the following formula:**
22 **STEP ONE: Determine the amount the Medicare program**
23 **would have paid the hospital for the claim at the time the**
24 **hospital provided the service or product comprising the claim**
25 **before reconciliation of the hospital's Medicare cost report by**
26 **the Medicare program.**
27 **STEP TWO: Multiply the amount calculated in STEP ONE**
28 **by the percentage of Medicare specified in section 1(k)(2)(B)**
29 **of this chapter."**
30 Page 37, line 35, delete "P.L.6-2012," and insert "HEA 1325-2013,".

1 Page 37, line 36, delete "150," and insert "11,".
2 Page 40, between lines 16 and 17, begin a new line block indented
3 and insert:
4 "(10) An individual who is not an employee of the state or a
5 political subdivision is considered to be a temporary employee of
6 the state for purposes of this chapter while serving as a member
7 of a mobile support unit on duty for training, an exercise, or a
8 response, as set forth in IC 10-14-3-19(c)(2)(B)."
9 Page 44, between lines 16 and 17, begin a new paragraph and insert:
10 "SECTION 16. IC 22-3-7-9.5 IS ADDED TO THE INDIANA
11 CODE AS A NEW SECTION TO READ AS FOLLOWS
12 [EFFECTIVE JULY 1, 2013]: **Sec. 9.5. (a) This section is effective**
13 **beginning July 1, 2014.**
14 **(b) For purposes of calculating the payment under section**
15 **9(m)(2) of this chapter to a hospital licensed under IC 16-21, the**
16 **payment owed for a claim submitted by the hospital for inpatient**
17 **or outpatient services or products must be the amount determined**
18 **under STEP TWO of the following formula:**
19 **STEP ONE: Determine the amount the Medicare program**
20 **would have paid the hospital for the claim at the time the**
21 **hospital provided the service or product comprising the claim**
22 **before reconciliation of the hospital's Medicare cost report by**
23 **the Medicare program.**
24 **STEP TWO: Multiply the amount calculated in STEP ONE**
25 **by the percentage of Medicare specified in section 9(m)(2)(B)**
26 **of this chapter."**
27 Renumber all SECTIONS consecutively.
