

# SENATE MOTION

**MADAM PRESIDENT:**

**I move** that Senate Bill 535 be amended to read as follows:

- 1           Page 2, line 38, delete "seven (7) members appointed" and insert
- 2           **"eleven (11) members appointed as follows:**
- 3                 **(1) Three (3) members appointed by the fiscal body of Clark**
- 4                 **County. Not more than two (2) members appointed under this**
- 5                 **subdivision may be affiliated with the same political party.**
- 6                 **(2) Two (2) members appointed by the executive of Clark**
- 7                 **County. The members appointed under this subdivision may**
- 8                 **not be affiliated with the same political party.**
- 9                 **(3) One (1) member appointed by the executive of the city of**
- 10                **Jeffersonville.**
- 11                **(4) One (1) member appointed by the executive of the city of**
- 12                **Charlestown.**
- 13                **(5) One (1) member appointed by the legislative body of the**
- 14                **town of Borden.**
- 15                **(6) One (1) member appointed by the legislative body of the**
- 16                **town of Sellersburg.**
- 17                **(7) One (1) member appointed by the legislative body of the**
- 18                **town of Utica.**
- 19                **(8) One (1) member appointed by the legislative body of the**
- 20                **town of Clarksville."**
- 21           Page 2, delete lines 39 through 42.
- 22           Page 3, delete lines 1 through 8.
- 23           Page 3, delete lines 16 through 29, begin a new paragraph and
- 24           insert:
- 25                **"(d) The initial terms of the initial members appointed to the**
- 26                **board are as follows:**
- 27                 **(1) One (1) of the members appointed under subsection (a)(1)**
- 28                 **shall serve an initial term of two (2) years, one (1) of the**
- 29                 **members appointed under subsection (a)(1) shall serve an**
- 30                 **initial term of three (3) years, and the other member**

- 1           **appointed under subsection (a)(1) shall serve an initial term**
- 2           **of four (4) years.**
- 3           **(2) One (1) of the members appointed under subsection (a)(2)**
- 4           **shall serve an initial term of one (1) year, and the other**
- 5           **member appointed under subsection (a)(2) shall serve an**
- 6           **initial term of three (3) years.**
- 7           **(3) The member appointed under subsection (a)(3) shall serve**
- 8           **an initial term of one (1) year.**
- 9           **(4) The member appointed under subsection (a)(4) shall serve**
- 10          **an initial term of two (2) years.**
- 11          **(5) The member appointed under subsection (a)(5) shall serve**
- 12          **an initial term of three (3) years.**
- 13          **(6) The member appointed under subsection (a)(6) shall serve**
- 14          **an initial term of four (4) years.**
- 15          **(7) The member appointed under subsection (a)(7) shall serve**
- 16          **an initial term of two (2) years.**
- 17          **(8) The member appointed under subsection (a)(8) shall serve**
- 18          **an initial term of three (3) years."**
