- 4 **(B) instructor must be certified by a national or state**
- 5 **firearms training organization as qualified to teach an**
- 6 **eight (8) hour handgun safety and training program.**
- 7 **(3) The program must provide at least five (5) hours of**
- 8 **instruction in the following:**
- 9 **(A) The safe storage, use, and handling of a handgun,**
- 10 **including safe storage, use, and handling to protect child**
- 11 **safety.**
- 12 **(B) Knowledge of ammunition.**
- 13 **(C) Handgun firing positions.**
- 14 **(D) Firearms and the law, including civil liability issues**
- 15 **and the use of deadly force. The instruction in the subject**
- 16 **described in this clause must be provided by an attorney or**
- 17 **a person trained in the use of deadly force.**
- 18 **(E) Avoiding criminal attack and controlling a violent**
- 19 **confrontation.**
- 20 **(F) All laws that apply to carrying a concealed handgun in**
- 21 **Indiana.**
- 22 **(4) The program must:**
- 23 **(A) provide at least three (3) hours of instruction on a**
- 24 **firing range; and**
- 25 **(B) require the firing of at least forty-five (45) rounds of**
- 26 **ammunition.**
- 27 **(5) The program must provide to a person who successfully**
- 28 **completes the program a certificate of completion stating**
- 29 **that:**
- 30 **(A) the program complies with this section; and**
- 31 **(B) the person has successfully completed the program.**
- 32 **The certificate must contain the printed name and signature**
- 33 **of the instructor who instructed the person.**
- 34 **(b) A person who grants a certificate of completion described in**
- 35 **subsection (a)(5) to an individual knowing that the individual did**
- 36 **not satisfactorily complete the program commits a Class D felony."**

- 38 Delete page 18.
- 39 Page 19, delete lines 1 through 10, begin a new paragraph and
- 40 insert:
- 41 SECTION 11. IC 35-47-2-21 IS AMENDED TO READ AS
- 42 FOLLOWS [EFFECTIVE JULY 1, 2013]: Sec. 21. (a) Retail dealers'
- 43 licenses issued by other states or foreign countries will not be
- 44 recognized in Indiana except for sales at wholesale.
- 45 (b) **Except as provided in subsection (c),** licenses to carry
- 46 handguns, issued by other states or foreign countries, will be

1 recognized according to the terms thereof but only while the holders
2 are not residents of Indiana.

3 **(c) This subsection applies only to a state or foreign country that**
4 **recognized an Indiana license to carry a handgun on March 1,**
5 **2013. Indiana will not recognize a license to carry a handgun issued**
6 **by a state or foreign country to which this subsection applies if the**
7 **state or foreign country:**

8 **(1) refuses to recognize a qualified or unlimited license to**
9 **carry a handgun issued by Indiana under section 3 of this**
10 **chapter; and**

11 **(2) recognizes an Indiana firearms reciprocity license issued**
12 **under section 3.5 of this chapter.**

13 **(d) The superintendent, in consultation with the attorney**
14 **general, may enter into agreements for reciprocal recognition with**
15 **any state."**
