

# SENATE MOTION

**MADAM PRESIDENT:**

**I move** that Senate Bill 555 be amended to read as follows:

- 1           Page 10, line 34, delete "excepted)." and insert ").".
- 2           Page 12, line 37, delete "years." and insert "**years in the case of a**
- 3 **four (4) year Indiana firearms reciprocity license. The**
- 4 **superintendent may adopt guidelines to establish a records**
- 5 **retention policy for a lifetime Indiana firearms reciprocity license.**
- 6 **A four (4) year Indiana firearms reciprocity license is valid for a**
- 7 **period of four (4) years from the date of issue. A lifetime Indiana**
- 8 **firearms reciprocity license is valid for the life of the individual**
- 9 **receiving the license. The Indiana firearms reciprocity license of**
- 10 **police officers, sheriffs or their deputies, and law enforcement**
- 11 **officers of the United States government who have been honorably**
- 12 **retired by a lawfully created pension board or its equivalent after**
- 13 **twenty (20) or more years of service, is valid for the life of these**
- 14 **individuals. However, a lifetime Indiana firearms reciprocity**
- 15 **license is automatically revoked if the license holder does not**
- 16 **remain a proper person."**
- 17           Page 16, delete lines 8 through 16 and insert "**under section 3.5 of**
- 18 **this chapter shall be issued for the purpose of the protection of life**
- 19 **and property and are valid for:**
- 20           **(1) four (4) years from the date of issue in the case of a four**
- 21 **(4) year Indiana firearms reciprocity license; or**
- 22           **(2) the life of the individual receiving the license in the case of**
- 23 **a lifetime Indiana firearms reciprocity license.**
- 24           **(b) In addition to the application fee, the fee for:**
- 25           **(1) a four (4) year Indiana firearms reciprocity license is**
- 26 **thirty dollars (\$30);**
- 27           **(2) a lifetime Indiana firearms reciprocity license is**
- 28 **seventy-five dollars (\$75); and**
- 29           **(3) a duplicate license to replace a lost or damaged license is**
- 30 **twenty dollars (\$20)."**

1 Page 16, between lines 27 and 28, begin a new paragraph and insert:  
2 **"(d) This subsection applies only to a person holding a lifetime**  
3 **Indiana firearms reciprocity license. At least one (1) time every**  
4 **four (4) years, the superintendent shall reevaluate a person who**  
5 **holds a lifetime Indiana firearms reciprocity license. If the**  
6 **superintendent determines that the person no longer:**  
7 **(1) has a proper reason for carrying a handgun;**  
8 **(2) is of good character and reputation;**  
9 **(3) is a proper person to be licensed; and**  
10 **(4) is:**  
11 **(A) a citizen of the United States; or**  
12 **(B) allowed to carry a firearm in the United States as a**  
13 **noncitizen of the United States under federal law;**  
14 **the superintendent shall revoke the person's lifetime Indiana**  
15 **firearms reciprocity license. If the superintendent revokes a license**  
16 **under this subsection, the superintendent shall provide the person**  
17 **with the superintendent's complete and specific reasons, in writing,**  
18 **for revoking the license. The superintendent may adopt rules under**  
19 **IC 4-22-2 to implement this subsection."**
