Synopsis: Indiana sportsmen's benevolence account. Specifies that the Indiana sportsmen's benevolence account administered by the department of natural resources, division of law enforcement, is a nonreverting account.

Effective: July 1, 2013.

SENATE BILL No. 364

A BILL FOR AN ACT to amend the Indiana Code concerning natural and cultural resources.

Be it enacted by the General Assembly of the State of Indiana:

- 1 SECTION 1. IC 14-9-5-4, AS AMENDED BY P.L.46-2010,
2 SECTION 1, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
3 JULY 1, 2013]: Sec. 4. (a) As used in this section, "account" means the
4 Indiana sportsmen's benevolence account established by subsection (b).
5 (b) The Indiana sportsmen's benevolence account is established
6 within the fund for the division of law enforcement to encourage
7 citizen participation in feeding the state's hungry through donations of
8 wild game that has been lawfully hunted.
9 (c) The account consists of:
10 (1) gifts;
11 (2) donations;
12 (3) proceeds derived from marketing by the division of law
13 enforcement of goods related to the feeding of the state's hungry
14 through donations of wild game under subsection (a); and
15 (4) donations collected under IC 14-22-12-1(c).
16 (d) The expenses of administering the account shall be paid from
17 money in the account.

- 1 (e) The division of law enforcement shall:
- 2 (1) conduct a publicity campaign relating to feeding the state's
- 3 hungry through donations of wild game;
- 4 (2) coordinate with nonprofit entities and other entities created
- 5 with goals of feeding the state's hungry;
- 6 (3) coordinate with nonprofit entities to use the money collected
- 7 under IC 14-22-12-1(c) to assist meat processors in processing
- 8 donations of wild game related to feeding the state's hungry; and
- 9 (4) engage in any other activities to further the goals of this
- 10 section.
- 11 (f) The treasurer of state shall invest the money in the account not
- 12 currently needed to meet the obligations of the account in the same
- 13 manner as other public money may be invested. Interest that accrues
- 14 from these investments shall be deposited in the account.
- 15 (g) **Money in the account at the end of a state fiscal year does**
- 16 **not revert to the state general fund.**
